The Senior program service consists of providing a facility, open to the public, for socialization, lectures, and subsidized meals to senior citizens at various times throughout the month. There are hundreds of seniors who participate in the Senior program.

The language program provides facility and teachers for a German language program for children in kindergarten through 8th grade.
