MGS held its 38th consecutive annual conference involving practitioners and researchers from a variety of disciplines, including health and human service providers, academics, researchers and older adults. Attendance was 301. The theme was Recruiting, Retaining, and Retraining the Workforce for an Aging Society, keynoted by Jacquelyn B. James, Ph.D., Director of Research, Sloan Center on Aging Work, Boston College. The conference featured 11 educational sessions, 6 sponsors, and 31 exhibitors.

The annual Gerontologist of the Year award was presented, along with three scholarships awarded to higher education students majoring in a gerontology related field in Minnesota. This conference allows practitioners, researchers, faculty and students to gain information on evidenced-based services to seniors, to learn about relevant research that improve results, and to highlight new services that meet emerging and critical issues, such as elder abuse. Attendees receive continuing education credits for their participation in the conference

Education is a primary focus of MGS. To fulfill this mission, 11 state-wide webinars were held. Topics are selected by a committee of gerontologists and aging service professionals and included: Alzheimer's, Vulnerable Adult Justice, Work Force Issues, Culture Change, Hearing Issues, Bi-Polar Disorder and Geriatrics, Hoarding Issues and Older Adults, Ethics, Using Yoga to Manage Chronic Pain, and Aging Issues. Over 900 individuals from across the state participated in webinars, with an average attendance of 82 per webinar. Attendees are eligible to receive continuing education credits. In addition, information was shared through a newsletter, email alerts and on the MGS website at www.mngero.org.
