### (1) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Dan Gibbons Turkey Trot Foundation (the Foundation) is a 5K race fundraising foundation established to raise money to donate to other organizations to provide relief and food for families in need for the holiday season. The 5K race is held annually on Thanksgiving Day in Elmhurst, Illinois.

The financial statements were available to be issued on DATE, with subsequent events being evaluated through this date.

#### Accounting Method -

The accompanying financial statements have been prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Under the cash basis, the only asset recognized is cash, and no liabilities are recognized. All transactions are recognized as either cash receipts or disbursements, and noncash transactions are not recognized. The cash basis differs from generally accepted accounting principles primarily because the effects of outstanding payables and receivables at the date of the financial statements are not included in the financial statements.

#### Basis of Presentation -

Financial statement presentation follows the recommendations of the Accounting Standards Codification (ASC), *Financial Statements for Not-for-Profit Organizations*. The statement of support, revenue and expenses - cash basis, reflects the change in unrestricted, temporarily restricted, and permanently restricted cash balances. The Foundation currently has no permanently or temporarily restricted net assets.

#### Revenue Recognition -

Contributions received are recorded as unrestricted, temporarily restricted or permanently restricted support, depending on the existence and/or nature of any donor restrictions in the period received. Donor restricted support is reported as an increase in temporarily restricted or permanently restricted cash receipts. Purpose restricted contributions are released from restrictions when the purpose of restriction is accomplished as cash disbursements from temporarily restricted cash receipts. The Foundation received no restricted contributions in 2014.

#### Cash and Cash Equivalents -

All highly liquid instruments with an original maturity of three months or less are considered to be cash equivalents.

#### Contributed Services -

A number of volunteers have donated significant amounts of their time in the Foundation's fundraising campaigns. No amounts have been reflected in the statements for donated services. Contributed services are noncash transactions, which are not recognized under the cash basis of accounting.

### Income Tax Status -

The Foundation is exempt from income tax under Section 501(c)(3) of the United States Internal Revenue Code and state laws. Accordingly, no provision for income taxes has been established

The Foundation files income tax returns in the U S federal jurisdiction and Illinois. With few exceptions, the Foundation is no longer subject to U.S. federal, state and local, or non-U S income tax examinations by tax authorities for years before 2011. The Foundation does not expect a material change in unrecognized tax benefits in the next twelve months
