	THE NORTHEAST ENTREPRENEUR FUND HAS ONE PROGRAM AND THAT IS TO PROVIDE PROFESSIONAL DEVELOPMENT TO BUSINESS OWNERS IN THE SERVICE AREA AND PROVIDE LOANS TO SUPPORT THE BUSINESSES. IN 2014, TOTAL PROGRAM COSTS OF \$1,052,261 WAS EXPENDED TO PROVIDE SERVICES TO 550 PARTICIPANTS AND OF THOSE PARTICIPANTS 122 RECEIVED LOANS TO START, STABILIZE OR EXPAND THEIR BUSINESSES. A TOTAL OF 690 JOBS WERE IMPACTED DUE TO THE SERVICE PROVIDED ALONG WITH \$3,249,937 IN LOANS WERE DISBURSED OF WHICH 50% WERE LOW TO MODERATE INCOME BUSINESS OWNERS AND WERE NOT BANKABLE. NORTHEAST ENTREPRENEUR FUND ALSO HAS AN INITIATIVE GREENSTONE GROUP, WHICH IS A TEN-YEAR INITIATIVE OF THE NORTHEAST ENTREPRENEUR FUND THAT STARTED IN 2007. THE MISSION IS TO CREATE A CULTURE OF ENTREPRENEURSHIP AND INCREASE THE NUMBER OF HIGHLY SKILLED ENTREPRENEURS IN THE REGION CAPABLE OF BUILDING SUCCESSFUL COMPANIES IN SUFFICIENT NUMBERS TO CREATE INDIVIDUAL AND COMMUNITY WEALTH AND DRIVE EMPLOYMENT. THE GOALS OF THE GREENSTONE GROUP ARE TO REACH 500 ENTREPRENEURS OVER A TEN-YEAR PERIOD, TO CREATE A VIBRANT, SUSTAINABLE ECONOMY, AND TO ENHANCE THE QUALITY OF LIFE IN NORTHEASTERN MINNESOTA AND NORTHWESTERN WISCONSIN. SINCE THE PROGRAM STARTED SEVEN YEARS AGO, 318 ENTREPRENEURS HAVE PARTICIPATED IN THE PROGRAM.
