During 2014, Youth Service International Inc. conducted four educational seminars for high school students to prepare them for high school and college. The main goal is to instill in them a desire to develop their talents to better serve others. Three leadership camps with similar educational aims were also sponsored for grade school students. During the year, there were 370 participants in these programs.

During 2014, in partnership with another tax-exempt organization, Youth Service International Inc. conducted programs similar to those described in 4a and 4b above for girls.
