

The vision of Koinonia House National Ministries (KHNM) is to glorify God through the redemption of our neighbors in prison by the gospel of Jesus Christ and their continued discipleship out of prison, thus reducing the recidivism rate. Our mission is to bridge the gap between the Christian inmate and the local church by facilitating the integration of the former inmate into the church, workplace, and society through biblical discipleship.

IN-PRISON MINISTRIES: In 2014, KHNM conducted 15 Freedom God's Way events in 14 adult correctional centers for over 1,700 men in the Illinois Department of Corrections. (Unfortunately, the weekend scheduled for the women's prison was cancelled due to a flu outbreak at the facility.) The focus of these multi-day events is to present the Gospel of Jesus Christ and prepare inmates for their return to society through practical Bible teaching, life skills, singing, story-telling, confession of sins, and communion. Christian literature and Bibles are distributed when allowed. Also in Illinois, KHNM team members conducted 4 worship services at Danville Correctional Center, participated in Easter services at Stateville Correctional Center, and one of our board members and a local pastor participated in a Theology Conference with the Divine Hope Reformed Theological Seminary at Danville Corr. Ctr. Regular visits were made to 4 men at the DuPage County Jail and many inmates were ministered to through correspondence. Beginning in August, God opened the doors for a new monthly ministry of cell-by-cell visitation for offenders in Pontiac Corr. Ctr. who are in restricted housing, being confined 24/7 except for limited shower and exercise time. Ministry in other states included speaking to 35 men & 25 women in the Carter County Detention Ctr in TN, to 50 men in Wise County Correction Ctr #18 in VA, to a large group of men in the Colorado Territorial Correctional Facility in Canon City, CO.

MEET ME AT THE GATE: Since 1997, KHNM has been working with churches, organizations and individuals in ministering to Christian neighbors coming out of prison for whom no family-home-based program was available. In 2014, KHNM acted as a consultant in varying ways to 16 groups or individuals seeking to help people just released from prison. A highlight of the year was participating via video in a conference in California on post-prison ministry.

In 2014, KHNM staff assisted 13 individuals with their reentry into society. Considerable time was also devoted to working with local churches in seeking ways to respond to Christians who are former sex offenders and now desire to be part of the local church.

We praise God for the ways He is working through our main ministry vehicle of Radical Time Out (RTO), a weekly dinner and Bible study. Those coming from prison, those on their way to prison, and even those currently in prison (via cell phone) gather with family members of incarcerated individuals and other church members for food, fellowship, and biblical discipleship.

Average attendance at RTO grew from 70 in December 2013 to 100 in December 2014. Visit www.RadicalTimeOut.info for stories and more information.

GENERAL MINISTRIES: Expenses in this category cover activities such as helping families of incarcerated individuals, educating the public on the needs of people returning to society from prison, and ministering to donor families. In 2014, KHNM staff assisted 17 individuals and families of the incarcerated through formal and informal advisory sessions. KHNM staff members also ministered in 11 churches and Bible conferences in Illinois, New Jersey, Tennessee, and Virginia.
