JOBS NOT JAIL PROGRAM SPONSORED THROUGH STATE APPROPRIATIONS SINCE 2012 HAS BEEN VERY SUCCESSFUL. THIS PROGRAM OFFERS FATHERS WHO ARE BEHIND IN CHILD SUPPORT PAYMENTS AN ALTERNATIVE TO INCARCERATION. THROUGH EMPLOYMENT TRAINING THESE FATHERS CAN OBTAIN WORK AT A LIVING WAGE WHICH IN TURN ENABLES THEM TO SUPPORT THEIR CHILDREN. IN 2014 THIS PROGRAM GAVE 633 MEN THE OPPORTUNITY TO GAIN EMPLOYMENT AND MEET THEIR CHILD SUPPORT OBLIGATIONS RATHER THAN GOING TO JAIL. THIS RESULTED IN A SAVINGS TO TAX PAYERS OF \$5,064,000.
