Wildlife Guardians is a charitable organization whose mission is to help promote the survival and well-being of the lion and other imperiled African wildlife species.

Lion Guardians: a \$275,000 grant provided financial support to Lion Guardians whose work contributes to Wildlife Guardians' objectives of protecting African lions. Lion Guardians is a non-profit limited liability corporation in Kenya working to conserve lions in Southern Kenya and northern Tanzania by recruiting young, non-literate Maasi warriors to become actively engaged in protecting lions rather than killing them. Lion Guardians monitor lion movements, warn pastoralists when lions are in the area, recover livestock, reinforce protecting livestock fencing and intervene to stop lion hunting parties. Collectively these efforts lead to reduction in the loss of livestock, which, in turn, enhances the livelihoods of the local people and builds tolerance for lions and other carnivores.

Niassa Carnivore Project: Wildlife Guardians awarded a \$40,000 grant to the Niassa Carnivore Project, whose work contributes to Wildlife Guardians' objective of protecting African lions. This grant was used to promote lion conservation in Mozambique by reducing the number of lions killed in illegal bush-meat snares in the Niassa National Reserve.

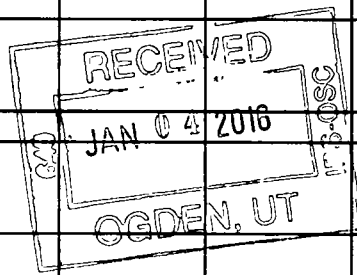
