The preparation process is led by a senior staff accountant within the Financial Reporting group and coordinated with various other senior leadership individuals within the credit union. Specifically the manager of Human Resources participates in the process through support in gathering specific information related to the board and the compensation of the credit union officers information. Once the return is prepared, it is reviewed by the Vice President of Accounting. A final review of the 990 is completed and signed off by the Chief Financial Officer/ Senior Vice President of Finance. Once the return is completed and filed, management communicates to the Board of Directors that we have met the filing requirements of the form 990 with the IRS but a copy is not provided.
