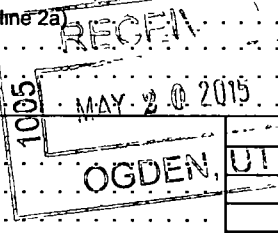

These books continue to emphasize the importance of character development, ethical integrity, and a spirit of service to all. The books also promote a greater understanding of the dignity of all persons, especially the most vulnerable in our society, such as the unborn, children, the sick, the imprisoned, and the elderly, as well as books that suggest ways to strengthen family and friendship ties for the purpose of improving social, economic, and religious life in the US society.

Other Scepter's selection of titles emphasizes the fundamental aspects of religious life: prayer, sincerity, self-denial, and a spirit of service to others. Since its publishing focus is related to a message that remains outside the mainstream, it must make a greater effort to promote these materials with better marketing in order to reach individuals already receptive to this message as well as those who might be led to a greater awareness of its importance.

Other During 2014 Scepter released several new books that help people in their day-to-day struggles to improve both their own lives and the lives of others. It released three biographical works. The first is a video called "Everyday Holiness: The Life of Father Joseph Muzquiz". This is a documentary of one of the first members of Opus Dei to begin it's apostolates in the United States. The second book is a biography of Dora del Hoyo called "A Lighted Lamp". Del Hoyo was one of the first women members of Opus Dei. Thirdly, Scepter released a biography of Alvaro del Portillo who was recently canonized by Pope Francis. Del Portillo was the first successor to St. Josemaria, the founder of Opus Dei. Additionally, Scepter released several other books that help people in their spiritual growth. "Thirsting for Prayer" by Fr. Jacques Philippe helps men and women to find peace and direction in their lives through the practice of daily prayer and meditation. A new edition of "Virtuous Leadership" by Alexandre Havard was also released. This book helps to discover that leadership can and should be exercised by all, no matter one's position in society. "Created for Greatness", also by Havard,

Other explains the importance of the virtue of magnanimity in the flourishing of individuals and society. Scepter also released a book called "The Faith Explained Today" by Joe Babendreier, which lays out the basics of the Catholic faith in modern terminology. Finally, Scepter published an inspirational book about the Catholic belief in purgatory called "Visions of Purgatory".

Other Scepter continued to offer free books to prisoners upon request. It is the organization's belief that society greatly benefits when prisoners have access to these books, as they aid greatly in the reformation of their character, which is important to their eventual reintegration into society.

Other Scepter continues to develop its list of electronic books and its own electronic distribution system. These electronic books are especially helpful as they are of lower cost and greater convenience to readers.
