**ABATEMENT OF LATE FILING PENALTIES**  
**DUE TO REASONABLE CAUSE**

The Robert E. Gallagher Charitable Trust ("CT") is requesting that any penalties for late filing be abated due to reasonable cause. On May 11, 2015, CPA contacted CT stating that as CT is still waiting for the Schedule K-1 from one of its investments (SSARIS Multi-Manager Absolute Return Fund, LLC), CT will need to file an extension. CPA explained that as CT properly paid sufficient estimated tax payments throughout the year, there is no expected balance due on the return; however, CT will need to make an estimated tax payment for tax year 2015. CT properly authorized CPA to file an extension. In addition to making the 2015 estimated tax payment on May 12, 2015 (see Attachment A), as instructed by CPA, CT contacted CPA to confirm that the extension was filed. CPA, believing this to be true, informed CT that the extension was filed.

CPA did, in fact, create the extension e-file using Thomson Reuters Go-System tax software on May 11, 2015 (see Attachment B). Though the extension e-file was created, it was inadvertently never submitted to the IRS. On May 22, 2015, CPA realized this error and, at which point, immediately submitted the extension e-file that had been originally prepared in a timely manner on May 11, 2015. This was, however, rejected by the IRS as it was filed late (see Attachment C). Anticipating a late filing penalty, CT is filing this Statement of Reasonable Cause with the filing of its Form 990-PF.

In summary, this late filing was solely due to an administrative oversight by CPA. CT exercised ordinary business care and prudence by following up with CPA, prior to the filing date, to confirm that the extension was e-filed. Based on the representation of CPA, CT understood that the extension was properly filed. CT's business care and attention is further evident by the fact that CT properly and timely made its 2015 estimated tax payment at that same time. The late filing was not due to CT's neglectfulness or carelessness. In addition, CPA has established an extra layer of checks and balances with respect to the e-filing process to ensure that such administrative errors do not occur in the future.
