The primary mission of the organization is to provide grants to public school educators in our community's two public school districts. Teachers complete a rigorous application process in which completed applications are blindly submitted to the grants committee. We take great care to make sure neither the applicant's name nor school is known during the grant review process. In 2014, grant applications received exceeded budgeted grant amounts by several thousand dollars. The grants committee carefully reviews each application to determine those that are best worthy of funds from budgeted amounts. Applicants awarded grants use the money to underwrite innovative teaching projects.
