We now have the ability to reach 4 billion people globally with these translations. All Web- and app-based Gospel sharing tools are freely available through online access. In 2014, several new projects were initiated to exponentially expand our Gospel reach for 2015 and 2016. Primarily, this will be accomplished through the design and construction of a new Web-based tech platform that will support our Global Partners and equip many more to share the Gospel. In addition, thousands of individuals have been the recipients of free Gospel tools through seminars, prison ministries, church plants, and food pantries. For example:

- We gave The Story to 6,000 Angola Prison inmates
- We gave away The Story app to 36,231 users
- We made The Story available to 196,992 readers via free online access
- We placed 1,055 copies of The Story ESV Bible in Thanksgiving food boxes for needy families in NYC
- We gave out 1,200 copies of The Story Bible during our NYC trips
