Access to Capital in the form of Business Loans The FACC closed 19 loans in CY2014 for a total of \$438,401 - averaging \$23,081 per loan Seventy-eight percent of these loans were made with Native American businesses with thirty-six located on a WI federally recognized Indian Reservation Approximately 200 business owners or representatives received FACC training and technical assistance during 2014 including classroom workshops and/or one-to-one technical assistance Post loan (risk mitigation) technical was provided to borrowers with 35 active loans in the FACC portfolio The FACC focused upon coalition building during 2014 including participating in a College of Menominee Nation "Native Entrepreneur Training Series" designed to provide college level business management training as part of the process to facilitate loan readiness and referral to Native CDFIs - specifically the FACC and Menominee-based NiiCaP A total of four (4) loan inquiry and two (2) loan closings resulted from this project
