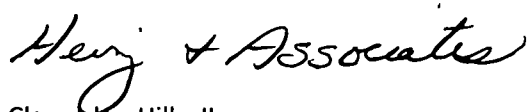

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2014

1. Nature of Activities

KIDS & CLAYS FOUNDATION is organized in the State of Illinois as a not-for-profit organization to raise funds for Ronald McDonald House Charities to improve the lives of children and their families by partnering with shooting sports enthusiasts to develop programs that generate funds to support this cause. It operates throughout the United States and funds raised are allocated to the various operating needs of Ronald McDonald House, Ronald McDonald House Family Rooms, and Ronald McDonald Mobil Medical Units.

2. Summary of Significant Accounting Policies

Basis of Accounting --- The accompanying financial statements have been prepared on the accrual basis of accounting.

Donations of Goods and Services --- Goods offered at auction and as raffle prizes are donated; they are recorded as both receipts and disbursements at their estimated fair market values. Services provided by volunteers do not meet criteria for recognition as contributed services and are therefore not recorded in the financial statements.
