1 The Parks and Recreation department of the City of Manchester, Iowa, held 3 separate concerts in the bandshell at Tirrill Park in June, July, and August. Hanson Foundation provided \$2000, \$2000, and \$1000 respectively for each concert. The performances were given by regional musical groups to broaden the musical experiences of the community. Since the concerts were offered free to those attending, there is no accurate count of patrons, but it is estimated that about 200 persons attended each of the three events.	5,000
2 The Foundation, in cooperation with the West Delaware Friends of Music organization (WDFOM), provided majority funding for a performance by a traveling musical act from Branson, MO. Attendance was approximately 250. The Foundation provided a grant to assist WDFOM in hosting regional performer, Jim McDonough, in a public concert held at the Hanson Auditorium in April. The attendance was estimated at 300. The Foundation provided partial support for a local presentation of the Bill Riley Talent Show, a state-wide effort to provide amateur performers with an opportunity to display their talents and earn a spot at the State Fair. Many local performers were able to participate and gain experience, and a small audience enjoyed the performances of local talent at Hanson Auditorium. In December, the Foundation was a sponsor of the Michael Thoma Christmas show, held at Hanson Auditorium, attended by approximately 150.	5,498
