In 2014, Tau Beta members helped supply and maintain the Center's "Closet O'Stuff", donated Easter baskets for the children of Teenaged Parents Program, planted the Center's beautiful garden, provided turkeys for Thanksgiving and gifts at Christmas and assisted in helping children create crafts for their caregivers for Mother's and Father's Day. Tau Beta members also read to children and provided various resouce materials for clients as well as parents and families through the Tau Beta Center for Discovery opened in June of 2006.

No one program that a Tau Beta member participates in is more important than another, no Tau Beta member receives compensation for his or her service at the Center and no records are kept to breakdown expenses for any particular project.

Tau Beta is organized as a Michigan nonprofit Corporation, on non-stock, membership basis, pursuant to the Michigan Nonprofit Corporation Act. The Bylaws of the organization provide that the voting members shall elect the Board of Trutees, which is the governing body of Tau Beta. The membership is self-perpetuating. Only Active and Life Members are entitled to vote for or propose candidates for membership or for the Board of Trustees. Non-Resident Members and Honorary Members have no right to vote for or propose candidates for membership or for the Board of Trustee.
