FIELD OF MEMBERSHIP INCLUDES ALL PERSONS WHO RESIDE, WORK, ATTEND SCHOOL OR WORSHIP IN ANY COUNTY IN MICHIGAN'S LOWER PENINSULA. FOUNDED BY A SMALL GROUP OF EDUCATORS, MSGCU OFFERS A FULL RANGE OF LOAN, SAVINGS AND CHECKING, CREDIT CARD, MORTGAGE AND INSURANCE PRODUCTS FOR CONSUMERS AND BUSINESSES. MSGCU CURRENTLY HAS 11 OFFICES IN MACOMB AND OAKLAND COUNTIES, MORE THAN 100,000 MEMBERS, 1.5 BILLION IN ASSETS AND A 97% SATISFACTION RATING FOR THE PAST 10 YEARS.
