1. Purpose of Organization

The International Institute for Secular Humanistic Judaism (IISHJ) was established in 1985 in Jerusalem to serve the needs of the growing movement of Secular Humanistic Judaism. Its three primary purposes are to train rabbis, leaders, educators and spokespersons, to commission and publish materials for the movement and to offer public seminars and Colloquia for education and inspiration. Since the North American Section was incorporated in 1985, it has ordained over 40 Leaders/madrikhim(ot)/vegvayzer and Rabbis.

While the IISHJ was originally envisioned as the center of a multi-national network of programs, its current activities are focused on supporting the work of the North American Section and its Israeli partner (since 2004), Tmura-IISHJ: the Institute for Training Secular Humanistic Rabbis and Jewish Leadership in Israel. The original IISHJ campus is located at the Ben and Lorraine Pivnick Center for Humanistic Judaism in Farmington Hills, a suburb of Detroit, Michigan. The IISHJ administrative office is in Lincolnshire, a suburb of Chicago, Illinois. Seminars are held at both the Lincolnshire and the Pivnick Center campuses, as well as with Secular and Humanistic Communities throughout North America.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accounts of IISHJ are maintained on the accrual basis.

Information regarding the financial position and activities of IISHJ are reported in three classes of net assets (as applicable): unrestricted, temporarily restricted or permanently restricted, the latter two of which are based on the existence or absence of externally (donor) imposed restrictions on contributions. Accordingly, net assets of IISHJ and changes therein are classified and reported as follows:

- Unrestricted Net Assets – Unrestricted net assets are not subject to donor-imposed stipulations. They include all activities of IISHJ, except for those that are temporarily or permanently restricted by donors. Board designated amounts are part of unrestricted net assets.
- Temporarily Restricted Net Assets – Temporarily restricted net assets are subject to donor-imposed stipulations that can be removed through the passage of time (time restrictions) or actions of IISHJ (purpose restrictions).

- Permanently Restricted Net Assets – Permanently restricted net assets are subject to the restrictions imposed by donors who require that the principal of this class of net assets be retained in perpetuity as an endowment with only the income to be reclassified to unrestricted net assets.

Cash and Cash Equivalents

IISHJ considers all highly liquid investments with an initial maturity of three months or less to be cash equivalents, excluding those amounts contained in the investment portfolios.

Allowance for Doubtful Accounts

Accounts receivable are stated net of an allowance for doubtful accounts. IISHJ estimated the allowance based on its historical experience of the relationship between actual bad debts and net amounts collected. There is no allowance needed currently.

Fair Value Measurements

Under GAAP, *fair value* is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). IISHJ utilizes market data or assumptions that market participants would use in pricing the asset or liability, including assumptions about risk and the risks inherent in the inputs to the valuation technique.

IISHJ's assessment of the significance of a particular input to the fair value measurements requires judgment and may affect the valuation of fair value of assets and liabilities and their placement within the fair value hierarchy levels.

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, maximizes the use of observable inputs, and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I measurements) and the lowest priority to measurements involving significant unobservable inputs (Level III measurements). The three levels of fair value hierarchy are as follows:

Level I Valuation based on quoted prices in active markets for identical assets or liabilities that a reporting entity has the ability to access at the measurement date, and where transactions occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level II Valuation based on inputs other than quoted prices included within Level I that are observable for the asset or liability, either directly or indirectly. Inputs include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets, or liabilities in markets that are not active, that is, markets in which there are few transactions, prices are not current, or prices vary substantially over time.

Level III Valuation based on inputs that are unobservable for an asset or liability and should be used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at the measurement date. This input, therefore, reflects IISHJ's assumptions about what market participants would use in pricing the asset or liability based on the best information available in the circumstances.

Property and Equipment

Property and equipment is recorded at historical cost. IISHJ capitalizes fixed asset additions over \$1,000. Depreciation is computed using the straight-line method for all property and equipment. The estimated useful lives in computing depreciation are as follows:

Maintenance and repairs, which neither materially add to the value of the property nor appreciably prolong its life, are charged to expense as incurred. Gains or losses on dispositions of property and equipment are included in the statement of activities and change in net assets. All current fixed assets are completely depreciated.

Impairment of Long-Lived Assets

IISHJ reviews its investment in long-lived assets for impairment whenever events or changes in circumstances indicate that the carrying value of such assets may not be recoverable. For assets held and used, if management's estimates of the aggregate future cash flows to be generated by a property (undiscounted and without interest charges and any estimated proceeds from the eventual disposition of the assets) are less than its carrying amount, an impairment loss has occurred. The amount of the impairment loss is equal to the excess of the asset's carrying value over its estimated fair value. The determination of undiscounted cash flows requires significant estimates by management. Subsequent changes in estimated undiscounted cash flows could impact the determination of whether impairment exists. No impairment loss has been recognized during the year ended December 31, 2014.

Contributions, Grants and Contracts

All contributions are considered to be available for unrestricted use unless specifically restricted by the donor, grantor or contracting agency. Amounts received that are designated for future periods or are restricted for specific purposes are reported as temporarily restricted or permanently restricted support that increases those net asset classes. Unconditional promises to give, which do not state a due date, are presumed to be unrestricted net assets. A donor restriction expires when a stipulated time restriction ends, when an unconditional promise with an implied time restriction is collected, or when a purpose restriction is accomplished. Upon expiration, temporarily restricted net assets are reclassified to unrestricted net assets and are reported in the statement of activities and change in net assets as net assets released from restrictions. Permanently restricted net assets include the principal amount of contributions accepted with the stipulations from the donors that the principal be maintained in perpetuity, with only the income therefrom to be expended for either general purposes or a purpose specified by the donor.

Income Taxes

IISHJ is exempt from federal and state income taxes under Section 501(c)(3) of the Internal Revenue Code and is not considered to be a private foundation. It is also required to recognize or derecognize in its financial statements positions taken or expected to be taken in a tax return on a "more likely than not" threshold. IISHJ does not believe its financial statements include any uncertain tax positions. IISHJ's income tax filings for the years 2011 and thereafter remain subject to examination by the Internal Revenue Service.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the relevant period. Actual results could differ from those estimates.

3. Lease Obligations

The Institute sublets office space from Kol Hadash Congregation at the same effective rate per square foot that the Congregation pays.

The Institute also rents space from the Birmingham Temple for a Michigan office. This is an annual arrangement and \$0 was paid for the year ended December 31, 2014.

4. Investments

The investments are held in a brokerage account and are composed of the following:

5. Concentrations of Credit Risk

Certain financial instruments potentially subject IISHJ to concentrations of credit risk. These financial instruments consist primarily of cash and cash equivalents and receivables. IISHJ maintains its cash in various bank deposit accounts which, at times, may exceed federally insured limits. IISHJ has not experienced any losses in such accounts. Concentrations of credit risk with respect to receivables are generally diversified due to the large number of entities and individuals composing IISHJ's program and donor base. IISHJ performs ongoing credit evaluations and writes off uncollectible amounts as they become known.

6. Advertising Costs

Advertising costs, used by IISHJ to promote its programs among the audiences it serves, are expensed as incurred. Advertising expenses for the year ended December 31, 2014 were \$555.

7. Employment Agreements

1 employee (an executive assistant), is under contract with Kol Hadash Humanistic Congregation for his services.

Kol Hadash bills IISHJ for any services this employee provides IISHJ at his effective hourly rate.

8. Compensated Absences

Employees of IISHJ are entitled to paid vacation, paid sick days, and personal days off, depending on job classification, length of service, and other factors. It is impracticable to estimate the amount of compensation for future absences, and accordingly, no liability has been recorded in the accompanying financial statements. IISHJ's policy is to recognize the costs of compensated absences when actually paid to employees.

9. Permanently Restricted Net Assets

\$191,107 was received by IISHJ as a result of the dissolution of a shared endowment fund that was owned by another entity (The Birmingham Temple). The principal amount of the funds are to be treated as Endowment, while the earnings received by the Organization are available for use at the discretion of the Board of Directors.

10. Subsequent Events

Subsequent events have been evaluated through June 17, 2015 which is the date the financial statements were available to be issued and there is one subsequent event requiring recognition and/or disclosure. Regarding Note 3 - Lease Obligations, the Institute and Birmingham Temple let their annual lease lapse during 2014 which went unrecognized by both parties. As a result, the parties entered into negotiations for a new lease and payment for past usage. Rent of \$3,100 was accrued as of December 31, 2014 to recognize the liability that was previously unrecorded.
