Our mission is to raise money for green projects and to educate the public about the most pressing environmental issues facing the planet today. Our overall goal is to help conserve, protect, and improve the environment through funding green projects and through education, which includes STEM, nutrition and conservation education in K-12 schools.

Green Our Planet (GOP) helped fund and install 40 outdoor garden classrooms in the Clark County School District. GOP now works with 61 schools with more than 40,000 students in attendance. Each garden classroom consists of 5 raised garden beds, 8' x 4' in size, consisting of 14,112 square feet of garden able to produce 100 pounds of vegetables twice a year. The 61 gardens are able to produce a total of 12,200 pounds of produce a year. Many studies have shown that students taught in outdoor teaching gardens score considerably higher on tests for math, science, and other subjects. Green Our Planet was awarded the American Honda Foundation Grant which allowed us to fund 12 Clark County School District Teachers and 3 farmers from Garden Farms to create a STEM curriculum to Nevada State Standards and Next Generation Science Standards which is now being used by 51 elementary schools. GOP also partnered 40 schools with a chef who went into the schools and prepared and cooked food from the gardens with the students. In additional, Green Our Planet helped 26 schools implement and run farmers markets at their respective schools in 2014.
