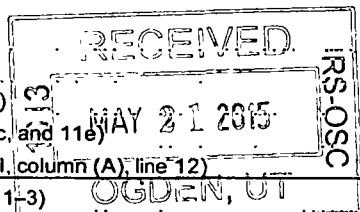

**RESTATED AND AMENDED BYLAWS OF
ELEVATE, INC.**

These Restated and Amended Bylaws will become effective on January 1, 2014, the date that Nova Services, Inc. obtains significant assets from Council on Alcohol and Other Drug Abuse of Washington County, Inc.

**ARTICLE I
PURPOSE**

Elevate, Inc. (the "Corporation") is created and shall be operated exclusively to provide a continuum of services which empowers and supports responsibility, accountability and dignity for individuals, families and communities, and at all times shall operate consistent with the requirements of 501(c)(3) of the Internal Revenue Code of 1986 (the "Code").

**ARTICLE II
BOARD OF DIRECTORS**

2.1. General Powers. The management, control and operation of the affairs and properties of this Corporation are vested in the board of directors of the Corporation (the "Board"). The Board may adopt such rules and regulations for the conduct of business as deemed advisable, including but not limited to Authority Guidelines for the Corporation, and may in the execution of the powers granted, delegate certain authority and responsibility to agents of the Corporation.

2.2. Composition of the Board. The Board shall consist of at least ten (10) but not more than fifteen (15) persons (the "Directors"). The exact number of Directors shall be determined from time to time by resolution of the Board.

- (a) The Initial Board under these Restated Bylaws shall consist of certain Directors from both Nova Services, Inc. and Council on Alcohol and Other Drug Abuse of Washington County, Inc., who shall serve the terms designated by the Board at the time these Bylaws are adopted. As the terms of the Initial Directors expire or Directors choose to resign, new Directors shall not be elected until the number of Directors reaches fifteen (15) or fewer. When the Initial Board consists of fifteen (15) or fewer Directors, the Board shall elect Directors who support the purpose of the Corporation and who shall serve the terms set forth in these Bylaws.
- (b) If the immediate Past President is no longer a Director, he or she may choose to attend Board meetings in an ex-officio, non-voting capacity until the subsequent Past President becomes the current immediate Past President. The immediate Past President shall receive notice of all meetings of the Board and may participate in all discussions but shall have no vote.

- (c) When vacancies among the Directors occur by reason of death, resignation, failure of qualification, removal, or otherwise, the number of Directors shall be reduced by such vacancies until qualified replacements are named by the Board. At no time shall the number of Directors be fewer than three (3).

2.3. Term. Each Director shall serve a term of three (3) years, or until such Director's successor is appointed and qualified. The terms of the Directors, including the terms of the Initial Board, shall be staggered such that approximately one-third (1/3) of the Board shall conclude their terms each year. Directors may be reappointed for two consecutive terms. After an absence of one (1) year from the Board, an individual shall become eligible again for election to the Board.

2.4. Resignation and Removal. A resignation by a Director must be in writing and is effective when received by the President or Secretary. Any Director may be removed from the Board for any reason by a vote of a majority plus one (1) of all Directors who are not the subject of removal. Replacements shall be nominated and elected consistent with Section 2.2. Two consecutive unexcused absences may be reason for removal from the Board of Directors by majority vote of the Board.

2.5. Annual Meeting. The annual meeting of Board shall be held in September of each year on such day and at such time as determined by the President (the "Annual Meeting"). The purpose of the Annual Meeting is to elect Directors and officers, and for the transaction of such other business as may come before the meeting.

2.6. Regular and Special Meetings. Regular meetings of the Board shall be held at such times as the President may designate, at such other place as the President may designate. The Board shall hold a minimum of six (6) regular meetings per year. Special meetings of the Board may be called by the President, or by two (2) or more Directors at such time and place as the President or Directors calling the meeting may specify and in accordance with the notice requirements of Section 2.13.

2.7. Quorum. To establish a quorum of the Board, a majority of all Directors then in office must be present.

2.8. Manner of Acting. Except where otherwise provided by law or in these Bylaws, the act of a majority of all Directors then in office is the duly authorized act of the Board.

2.9. Written Consent. In accordance with Section 181.0821, Wis. Stats., any action that would be taken at a meeting of the Board may be taken without a meeting if a consent in writing setting forth the action to be taken, is signed by at least two-thirds (2/3) of all of the Directors, provided all Directors receive notice of the text of the written consent and of its effective date and time. Any such consent signed by two-thirds (2/3) of all of the Directors has the same effect as a two-thirds (2/3) vote taken at a duly convened meeting of the Board at which a quorum is present and may be stated as such in any document filed with the Wisconsin Department of Financial Institutions. For purposes of this section, pursuant to § 181.0821(1r) of the Wisconsin Statutes, "in writing" includes a communication that is transmitted or received by electronic means, including electronic mail ("email"), and "signed" includes an electronic

signature, as defined in §181.0103(10p) of the Wisconsin Statutes, as amended from time to time.

2.10. Compensation. Directors will not be paid compensation for their services as Directors, provided that nothing in these Bylaws will be construed to prohibit payment of compensation to an individual who serves as a Director for services rendered to the Corporation in another capacity or reimbursement of expenses related to undertaking the Corporation's business.

2.11. Meetings by Electronic Means of Communication. The Board or any committee of the Board may conduct any regular or special meeting by use of any electronic means of communication provided: (1) all participating Directors may simultaneously hear or read each other's communications during the meeting or (2) all communication during the meeting is immediately transmitted to each participating Director and each participating Director is able immediately to send messages to all other participating Directors. Before the commencement of any business at a meeting at which any Directors do not participate in person, all participating Directors shall be informed that a meeting is taking place at which official business may be transacted. Participation in such manner shall constitute presence in person at such meeting for the purposes of these Bylaws.

2.12. Notice. Notice of meetings may be given by email, unless Directors request to receive notices via mail or personal delivery. Special meetings must be preceded by at least forty-eight (48) hours notice to each Director if notice is given by email, or seventy-two (72) hours notice if notice is given by mail or private carrier. Notice need not be given of regular meetings of the Board, except a regular meeting at which the amendment or repeal of the Bylaws or the adoption of new Bylaws or the removal of a Director is to be considered requires seven (7) days advance written notice. Written notice shall be deemed given at the earlier of the time it is received or at the time it is deposited with postage prepaid in the United States mail or delivered to the private carrier.

2.13. Director Conflict of Interest. The Board shall comply with the Conflict of Interest Policy that is attached as Exhibit A, as amended from time to time.

ARTICLE III OFFICERS

3.1. Officers. The officers of the Corporation shall be a President, a Vice-President if such position is filled, a Secretary, a Treasurer, and such other officers or assistant officers as the Directors may from time to time elect or appoint. The initial officers of the Corporation shall consist of certain Directors from both Nova Services, Inc. and Council on Alcohol and Other Drug Abuse of Washington County, Inc. The Board may elect such other officers as it deems desirable. The officers shall be chosen from among the Directors.

3.2. Election, Term of Office and Removal.

- (a) The Board shall elect the officers of the Corporation for two (2) year terms, or until the Board again elects new officers, whichever occurs first.

Officers may be reelected once to serve a maximum of two (2) consecutive terms.

- (b) Any officer of the Corporation may be removed from office at any time for any reason by a majority of all of the other Directors who are not the subject of removal.

3.3. President. The President shall give active direction and have control of the business and affairs of the Corporation. He or she shall perform all duties incident to the office of President as may be prescribed by the Board of Directors. He or she shall preside at meetings of the Board.

3.4. Vice-President. The Vice-President shall have such duties as determined from time to time by the Board. The Vice-President shall discharge the duties of the President in the event of his or her absence or inability to act.

3.5. Secretary. The Secretary shall sign documents of the Corporation from time to time as required and shall see that minutes of the meetings of the Board are taken and maintained; see that notices are duly given in accordance with the provisions of these Bylaws or as required by law and be custodian of the corporate records.

3.6. Treasurer. The Treasurer also shall see that an adequate and accurate accounting system is maintained and that financial reports are presented to the Board. The Treasurer shall advise the Board on the handling of the Corporation's monies and investments and perform such additional duties as may be assigned to the Treasurer by the Board or the President.

3.7. Authority of Officers. The officers may sign and execute, in the name of the Corporation, any instrument or document consistent with the general delegation of authority for that position, provided that such authority is consistent with any other instrument or document specifically authorized by the Board of Directors, including the Authority Guidelines, which are attached to these Bylaws as Exhibit B.

ARTICLE IV COMMITTEES OF THE BOARD OF DIRECTORS

The Board may have an Executive Committee and such other committees as determined by the Board.

4.1. Executive Committee. If the Executive Committee is formed, it shall consist of the President, the Vice-President if such position is filled, the Secretary, the Treasurer, and such other Directors as the officers may from time to time elect or appoint. The Executive Committee shall consist of up to five (5) individuals, and shall be comprised of only Directors. The Executive Committee shall have and may exercise, when the Board is not in session and without specific designation, all of the powers of the Board in the management of the affairs of the Corporation, except action with respect to election of officers or the filling of vacancies on the Board or on committees. The immediate Past President may choose to attend Executive Committee meetings in an ex-officio, non-voting capacity until the subsequent Past President becomes the current immediate Past President. The immediate Past President shall receive

notice of all meetings of the Executive Committee. The immediate Past President may participate in all discussions but shall have no vote.

4.2. Other Committees. The Board may form other committees, which may consist exclusively of Directors or include both Directors and non-Directors. Any committee that does not consist entirely of Directors shall be chaired by a Director, unless otherwise determined by the Board. All committees shall have only the authority specifically delegated to it by the Board.

ARTICLE V EXECUTIVE DIRECTOR

The Corporation is authorized to employ an Executive Director and such other persons as it deems necessary. The duties, responsibilities, and compensation of the Executive Director shall be at the direction of the Board. The Executive Director shall receive notice of and attend all meetings of the Board except during those parts of meetings when the subject is the Executive Director or any issue related to the Executive Director's employment. The Executive Director may participate in all discussions but shall have no vote.

ARTICLE VI CONTRACTS, CHECKS, DEPOSITS AND FUNDS

6.1. Checks, Contracts. The Board is authorized to select such depositories as it shall deem proper for the funds of the Corporation and shall determine, by resolution of the Board, who shall be authorized on behalf of the Corporation to sign bills, notes, receipts, acceptances, endorsements, checks, releases, contracts and documents. Unless otherwise determined by the Board, such authority relating to checks and contracts shall be as set forth in the Authority Guidelines, attached as Exhibit B.

6.2. Books and Accounts. The Corporation shall keep or cause to be kept correct and complete books and records of account and also keep minutes of the proceedings of the Board and its committees. In addition, the Corporation shall cause to be filed the necessary reports, tax returns or other documents as may be required by law on its own behalf.

ARTICLE VII INDEMNIFICATION

The Corporation shall, to the fullest extent authorized by Chapter 181, Wis. Stats., indemnify each Director and officer of the Corporation against reasonable expenses and against liability incurred by a Director or officer in a proceeding in which he or she was a party because he or she was a Director or officer of the Corporation. These indemnification rights shall not be deemed to exclude any other rights to which the Director or officer may otherwise be entitled, including the limitation from liability provided to Directors and officers under Chapter 181. The Corporation shall indemnify any employee who is not a Director or officer of the Corporation, to the extent the employee has been successful on the merits or otherwise in defense of a proceeding, for all reasonable expenses incurred in the proceeding if the employee was a party because he or she was an employee of the Corporation. The Corporation may, to the fullest extent authorized by Chapter 181, Wis. Stats., indemnify, reimburse, or advance expenses of Directors, officers, or employees.

**ARTICLE VIII
FISCAL YEAR AND TERM YEAR**

The fiscal year of the Corporation is the calendar year. The terms of the officers and Directors shall be the same as the fiscal year, unless otherwise determined by the Board.

**ARTICLE IX
AMENDMENTS TO THE BYLAWS**

These Bylaws may be amended or repealed and new Bylaws may be adopted upon the approval of two-thirds (2/3) of all Directors then in office and with at least seven (7) days notice.

**ARTICLE X
DISSOLUTION**

The Corporation shall be dissolved upon the approval of two-thirds (2/3) of all Directors then in office and with at least seven (7) days notice. Upon dissolution, the assets shall be distributed in accordance with the Corporation's Articles of Incorporation.
