NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2014 AND 2013

1. SUMMARY OF ACCOUNTING POLICIES:

The Organization, which is engaged in providing the necessities (food, clothing, shelter, medical services) to troubled people (transients, homeless, needy, etc.) on a temporary basis and also providing ongoing retreats for young people and adults in the Oshkosh and surrounding area, maintains its accounts on the cash method of accounting; consequently, certain support and revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred. Accounting principles followed by the Organization and the methods of applying those principles which materially affect the determination of assets, liabilities and changes in net assets are summarized below:

Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Contributions

Contributions received are recorded as unrestricted, temporarily restricted, or permanently restricted net assets depending on the existence or nature of any donor restrictions.

Income Taxes

The Organization is a not-for-profit organization that is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code and classified by the Internal Revenue Service as other than a private foundation. The Organization files Form 990 "Return of Organization Exempt From Income Tax." The returns filed for years 2011 through 2014 are still open to examination by the Internal Revenue Service. Management believes that there are no significant tax positions that would be challenged by the taxing authorities.

Cash and Cash Equivalents

For purposes of the statements of cash flows, the Organization considers all highly liquid investments available for current use with an initial maturity of three months or less to be cash equivalents.

Advertising

Advertising costs are expensed when paid. Total advertising costs paid during 2014 and 2013 were \$6,645.39 and \$6,837.95, respectively.

Functional Allocation of Expenses

The cost of providing various programs and activities have been summarized on a functional basis in Exhibits 4 and 5. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

Property, Equipment and Depreciation

Property and equipment purchased are recorded at cost. Donated assets are capitalized at fair market value. Depreciation of buildings and equipment is provided over the estimated useful lives of the assets on a straight-line basis as follows:

3. MARKETABLE SECURITIES:

Investments in marketable securities with readily determinable fair values and all investments in debt securities are reported at their fair values in the statement of financial position. Fair market value was based on an unadjusted quoted price for identical assets in the active market as of the date of the financial statements. Unrealized gains and losses are included in the change in net assets.

As of December 31, 2014 and December 31, 2013, the Organization was holding \$3,170.27 and -0-, respectively in marketable securities as shown below:

4. DONATED MATERIALS AND SERVICES:

Donated materials and equipment are reflected as contributions in the accompanying statements at their estimated fair market value at the date of receipt. Food and supply donations and medical and miscellaneous supplies for 2014 were valued at \$349,280.78 and \$120,000.00, respectively, and have been recorded as support and revenue.

Food and medical supplies of \$370,000.00 and \$174,000.00, respectively, were also received during 2013.

No amounts have been reflected in the statements for donated services inasmuch as no objective basis is available to measure the value of such services and the other criteria for recognition have not been satisfied however, a substantial number of volunteers have donated significant amounts of their time in the Organization's program services and in its fund-raising campaigns. The Organization received more than 59,000 volunteer hours, in 2014 and 2013.

During 2014, a vehicle valued at \$2,274.00 was donated to the Organization. This donation is included in Contributions, gifts and grants.

5. LINE OF CREDIT:

The Organization had a \$20,000.00 line of credit of which \$20,000.00 was utilized as of December 31, 2012. The line of credit had a maturity date of August 2, 2013 and an interest rate at prime not to exceed 4%. The rate at December 31, 2012 was 4%. The credit line was secured by a general business security agreement. This credit line was paid off during 2013.

6. MORTGAGES AND NOTES PAYABLE:

Annual maturities of debt for the years 2015 through 2019 are \$79,300.00, \$86,300.00, \$46,349.98, \$2,500.00 and \$2,600.00, respectively.

Interest paid during the years 2014 and 2013 amounted to \$12,442.37 and \$13,020.35, respectively.

7. MARKETABLE SECURITIES DONATIONS:

The Organization receives various stocks and bonds as donations throughout the years. It is the policy of the Organization to sell these assets upon receipt, thereby, no gain or loss is realized on the sale of these donated investments. During 2014 and 2013, the Organization received \$3,145.78 and \$1,944.39, respectively. The 2014 donation of stocks, valued at \$3,145.78, are currently being held in the Organization's investment account. As of December 31, 2014, the stocks had a fair market value of \$3,170.27, with a \$24.49 unrealized gain. This gain is reflected in the Organization's net assets. The stocks donated in 2013 were sold upon receipt. These stock donations are included in contributions, gifts and grants reported on Exhibit 2 of the financial statements.

8. RENTAL INCOME:

The Organization rents space on a periodic daily basis to doctors needing to provide an opinion on a local individual. The Organization also received rental income for temporary housing. In addition, the Organization receives rental income from the executive director's family.

9. AGENCY PAYABLE:

Assets transferred to the Organization from other not-for-profit organizations specifying themselves or affiliates as beneficiary are recorded by the Organization as an asset and a liability. Changes in those assets are recorded as increases or decreases in the liability with no effect on the statements of support, revenues, expenses and changes in net assets.

10. CONCENTRATIONS:

Approximately 30% of the Organization's food and supplies support are contributed by two suppliers for 2014 and 2013. The majority of these contributions goes to support the peoples pantry operations under food service.

Approximately 90% of the Organization's medical supplies support are contributed by seven suppliers for 2014 and 2013.

11. COMMITMENTS:

The Organization has committed to support a school and mission over in Accra, Ghana via payments of \$1,100.00 per month for the sisters of the mission while assisting at Father Carr's Place 2-B, Ltd. This amount is included in the mission support on Exhibit 2 for 2014 and 2013. The annual disbursements for this commitment for the next five years are as follows:

13. RELATED PARTY TRANSACTIONS:

During 2014, the Organization paid a business owned by the financial director, \$4,546.00 for building repairs and maintenance. This amount was included in repair and maintenance expenses on the Statements of Support, Revenues, Expenses and Changes in Net Assets - Cash Basis.

The Organization also paid the treasurer \$660.00 and \$340.00, as an independent contractor for grant writing purposes during 2014 and 2013, respectively. This amount was included in professional fees on the Statements of Support, Revenues, Expenses and Changes in Net Assets - Cash Basis.

The Organization sold one of its vehicles to the executive director in November 2013 for \$500.00. This amount was paid in February 2014 and was recorded as a note receivable at December 31, 2013. This note was non-interest bearing.

14. SUBSEQUENT EVENTS:

Management has evaluated subsequent events through July 21, 2015, the date on which the financial statements were issued.
