Our mission at Marinette County Elderly Services is to assist older persons in maintaining a longer, healthier, and more fulfilled life

NUTRITION: Provides hot, nutritious meals (Congregate and Home Delivered) for elderly. Promotes physical health, needed socialization, nutrition-related counseling and education. Program provides information about additional concerns of aging. In 2014, 51,489 meals were served to 880 individual clients, and transportation (959 rides) to mealsites was provided for those lacking other means of transport. Of meals served, 32588 (63%) were provided to home bound, often frail elderly unable to cook or provide their own meals.

4b (Code:) (Expenses \$ 230172 including grants of \$) (Revenue \$ 231812)

TRANSPORTATION: Provides transportation via bus, van, and private auto for medical, social, nutrition, employment, personal business. Many clients are frail elderly and require private auto escort and/or wheelchair-lift assistance in accessing Agency vans and buses. In 2014 the Agency provided 6,476 one-way passenger trips of which 975 were for medical appointments (343 were for frail elderly) and 686 trips (disabled riders). The remainder included rides for nutrition, employment, education, and social/recreation.

4c (Code:) (Expenses \$ 114620 including grants of \$ 14019) (Revenue \$ 115242)

LEGAL AND BENEFIT COUNSELING: Provides support to individuals affected by Alzheimer's Disease and related dementias, including Support Groups and grants to affected individuals. Programs include Family Caregiver Support, Medical and Prescription Drug assistance, Community Outreach, Information and Assistance, Respite Care and funding for needed supplies, Energy (heating and cooling) Assistance. 19 Clients received full or partial grants through Alzheimer's and/or Family Caregiver Support Programs. There were about 3000 Information and Assistance contacts. About 500 Agency newsletters were distributed to clients and constituents. About 4500 contacts for National Family Caregiver Support Program, Alzheimer's Family Caregiver Support, and Legal and Benefit Counseling.
