Residential services provide a continuum of care options including five community based residential facilities (6-7 bed), 2 adult family homes (4 bed), 3 supervised apartments (6 bed) and an independent living support program Each resident has their own private room and is provided appropriate care, treatment and training based on their individual needs The 57 total beds provided 20,460 days of service in 2014 Reflecting the focus on community integration, residents participated in 11,106 community activities last year for an average of 195 activities per resident The independent living support program serves individuals living in their own homes or preparing to transition into an independent setting Five clients moved into a more independent living setting last year One-to-one services that included support and training components were provided to over 30 adults with disabilities in 2014 with 5,223 hours of service

Adult day and work services provide a variety of programs appropriate to the various functional levels of the population of adults with disabilities served The sensory stimulation program, serving adults with severe to profound disabilities, provided 22 individuals with a record 22,800 hours of service Adult day services include life skills and the seniors programs, providing daily living skills training and activities to adults with severe disabilities, served 33 individuals with 36,519 hours of service Work services provide assessment, training and employment to adults with moderate to severe disabilities and offered 65,963 hours of service to 68 individuals Evening/weekend recreation and leisure time activities programs directly integrate consumers into their community, with 12,128 hours of service provided to 85 participants 91% of participants achieved at least 2/3 of their personal program goals during 2014 The community employment program provided job placement services, a community based supported employment placement, work incentive benefit analysis, and an assessment service contracted for youth transitioning from Superior High School in 2014

Enterprses were created to act as a platform for the work services program and to meet the mission in serving consumers Marathon Industres and Bay Produce provided the environment for the employment and training of the 68 individuals enrolled in our work services program, resulting in them receiving \$117,698 in wages during 2014 Marathon Industres, begun in 1980, performs light assembly, packaging, labeling, and mailings through subcontracts with area businesses, as well as confidential paper shredding for 1964customers throughout the Twin Ports area The paper is then baled and recycled Bay Produce started in 1986 and operates two greenhouses using hydroponic technology to grow beefsteak tomatoes, grape tomatoes, and colorful bell peppers in a sustainable manner Wholesale distribution totaled 344,699unds of produce throughout the region in 2014 Other enterprses have included space rental, professional training and contracting personal care workers to a home health agency A total of 34,506 hours of personal care were provided during the year
