Provide non-emergency medical transportation to individuals needing specialized vehicles and/or assistance. The Tri-State Regional Ambulance, Inc. expanded their service level to La Crosse area by hiring on-call drivers and doubling availability. The organization continued to provide services to La Crosse, Monroe, Vernon, Richland, Crawford, Iowa, and Grant Counties utilizing 13 vans.

Tri-State Regional Ambulance provides primary emergency 911 response as well as emergency and non-emergency interfacility transport and intercept services. Tri-State Regional Ambulance, Inc. utilizes 8 ambulances, 22 paramedics, and 28 EMT's to make approximately 1900 transports annually using advanced medical protocols. We send ECG's or electrocardiograms to the hospitals via the internet to speed up the treatment of heart attack victims. In 2013, Tri-State Regional Ambulance, Inc. donated 35 unpaid standbys to help out the local communities.
