



With the exception of noncash contributions of marketable securities, the amortization of premiums and discounts of marketable securities and accrued payroll taxes, only income collected, costs and expenses paid, and assets and liabilities arising as a result of cash transactions are recognized. Therefore, accrued income and expenses, payables and deferred expenses, which would have been recognized under accounting principles accepted in the United States of America, have not been determined and are not recognized in the La Crosse Community Foundation's financial statements and Form 990 reporting.
