**Amended and Restated Articles of Incorporation
of
Camp Fire Minnesota a Minnesota nonprofit corporation**

We, the members of Camp Fire Minnesota, organized and chartered by Camp Fire as a council for the sole purpose of providing Camp Fire program to youth, adopt the following Amended and Restated Articles of Incorporation, which are in accordance with the Minnesota Nonprofit Corporation Act, and all amendments thereto (the "Act") and with the articles of incorporation and bylaws of Camp Fire National Headquarters, a national organization organized under the laws of the State of Missouri.

Pursuant to the provisions of Chapter 317A of the Act, the following Amended and Restated Articles of Incorporation (these "Articles") are hereby adopted and shall supersede and take the place of the existing Articles of Incorporation:

Article I

Name and Incorporator

The name of the corporation shall be: Camp Fire Minnesota.

The name and address of the incorporator is Marnie Wells, 4829 Minnetonka Boulevard, St. Louis Park, Minnesota 55416.

Article II

Purpose

The purpose for which the council is formed is exclusively charitable and educational in accordance with Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. Any references herein to any provisions of such code shall be deemed to mean such provision as now or hereafter existing, amended or supplemented, or superseded, as the case may be.

The sole purpose for which this corporation is formed is to serve as chartered council of Camp Fire to provide the Camp Fire program throughout its jurisdiction and to work to improve conditions in society that affect youth in accordance with the purpose of Camp Fire.

Article III

Powers

In furtherance of its purpose, the corporation shall have the following powers:

To hire, lease, buy, inherit or otherwise acquire and hold land, buildings, equipment or other or personal property for an office, program facility or similar purpose; to build, construct, operate and manage said property for the benefit of Camp Fire; and to rent, lease, mortgage or sell all or any part of such real or personal property acquired by said corporation.

To do, perform and supervise any and all things in furtherance of the general purposes herein before expressed and not inconsistent with the Minnesota Nonprofit Corporation Act, and to have and to exercise all the powers conferred by the laws of the State of Minnesota upon corporations formed under the laws pursuant to, and under which, this corporation is formed, as such laws are not in effect and may at any time hereinafter be enacted or amended.

Article IV

Registered Office

The registered office of this corporation shall be in the City of St. Louis Park, County of Hennepin, State of Minnesota, at 4829 Minnetonka Boulevard.

Article V

Meetings

There shall be at least one meeting of the corporation each year.

Article VI

Assets and Earnings (No Pecuniary Gain)

None of the assets or earnings of the corporation shall be paid or accrued for the benefit of any of its members, directors, officers or employees or any other individual, whether before, upon or after dissolution or liquidation, except as reasonable compensation for services rendered, property transferred or as reimbursement for expenses incurred in conducting its affairs.

No substantial part of the activities of this corporation shall be the carrying on the propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Article VII

Perpetual Duration

The period of duration of corporate existence of this corporation shall be perpetual, provided that a charter from Camp Fire National Headquarters is held by the corporation.

Article VIII

Board of Directors

The management and direction of the business and affairs of this corporation shall be vested in a Board of Directors. The number, qualifications, term of office, method of appointment or election, powers, authority, and duties of the directors of this corporation, the time and place of their meetings, and all other provisions with respect to them as are not inconsistent with the express provisions of the Articles of Incorporation shall be as specified in the Bylaws of this corporation.

Article IX

Dissolution

In the event of the dissolution or final liquidation of the corporation, after all liabilities and obligations of the corporation have been paid, satisfied, and discharged, or adequate provision made therefore, all remaining property and assets of the corporation shall be distributed, conveyed, assigned, or transferred to another Camp Fire council that is acquiring the jurisdiction or such remaining assets shall be transferred to Camp Fire National Headquarters to administer according to the bylaws of Camp Fire National Headquarters.

Article X

Amendments

These articles may be amended by the affirmative vote of a majority of the Board of Directors voting at a meeting at which a quorum is present (or by written action pursuant to the provisions of the Bylaws); provided that notice of such proposed amendment has been included in the notice of meeting.

CERTIFICATION OF ARTICLES OF INCORPORATION

These Amended and Restated Articles of Incorporation were adopted by the Board of Directors of Camp Fire Minnesota at a duly called special meeting on 4/7/2014, with quorum present as prescribed by bylaws.
