Annual Meeting and Regional Conferences The Academy's eight-day Annual Meeting is perennially the world's largest gathering of neurologists In 2014, attendance at the Annual Meeting in Philadelphia drew 12,907, the most attended Annual Meeting to date Of the meeting attendees, 62% were members followed by 38% Nonmembers More than 2,300 research abstracts were presented and leading experts on a vast array of neurologic diseases discussed the latest research results and clinical applications The meeting featured over 180 continuing medical education courses that were strongly attended by neurologists looking to update their knowledge and skills and prepare for recertification Programs also were dedicated to helping practicing neurologists and business managers run more efficient and effective offices and clinics The Academy also communicated its advocacy priorities and success and urged greater member participation The 2014 regional Fall Conference attracted 505 attendees, a declining number for the weekend-long meeting, down from 556 in 2013 There were many factors that contributed to the decline, different program topics that were not as popular, scheduling over Halloween weekend and a change of venue We anticipate the decline to discontinue in 2015 The Fall Conference provides updates on neurology diseases and practice management improvements for neurologists and practice managers, particularly those who need to fulfill annual continuing medical education requirements by year end A new conference was launched in 2014 - The Sports Concussion Conference This conference drew 479 attendees of those 269 were members, 176 nonmembers and 34 exhibitors The conference focused on combining the education and scientific breakthroughs impacting the diagnosis and treatment of concussion

Clinical Practice and Practice Guidelines In 2014, the AANI published one systematic review and three guidelines in Neurology(R) Two of these publications included evidence for the use of medical marijuana in neurologic diseases and received a strong amount of media coverage Published in March 2014, an evidence-based guideline on the use of complementary and alternative medicine (CAM) in multiple sclerosis found a range of evidence supporting or refuting the effectiveness of certain forms of CAM The evidence supporting efficacy varied in strength for oral pill and spray forms of medical marijuana, ginkgo biloba, magnetic therapy, and reflexology and applied to particular MS symptoms For a number of therapies, evidence was insufficient to judge efficacy A systematic review on medical marijuana in the treatment of selected neurologic disorders, published in April 2014 during the AAN's Annual Meeting in Philadelphia, PA, found the same levels of evidence for oral pill and spray forms of medical marijuana in MS The conclusions of the systematic review provided evidence to support an AAN medical marijuana position statement The guideline on CAM use in MS was the focus of an AAN study on the effectiveness of its dissemination techniques and was awarded a grant by the Agency for Healthcare Research and Quality Quality Measures and Clinical Registry In 2014, the AAN approved developing a clinical data registry for its members The AAN developed clinical quality measures on headache, muscular dystrophy, and epilepsy for neurologists to use for quality improvement

Continuing Medical Education Programs The AANI offers a number of resources to help neurologists with professional development and maintenance of certification (MOC), as required by the American Board of Psychiatry and Neurology The AAN provides continuing medical education-a necessary component of MOC and licensure-in print (Neurology, Continuum) and in digital formats (Neurology Podcast, Continuum Audio, NeuroSAE, Practice Management Webinars), as well as through onsite programs at the Annual Meeting and regional conferences The number of AAN members subscribing to or participating in these programs has increased Other new, and increasingly popular, AAN MOC resources include the interactive practice improvement program NeuroPI, and the online-only education program NeuroLearn, which offers users a personalized education experience
