IN 2014, THE AGENCY SERVED 2,802 INDIVIDUALS IN ITS EMPLOYMENT, JOB PLACEMENT, SCHOOL-TO-CAREER TRANSITION, DAY TRAINING AND HABILITATION, HOMELESSNESS AND HOUSING SUPPORT PROGRAMS. IN JUST 2014 ALONE, RISE FACILITATED 391 COMPETITIVE JOB PLACEMENTS. DAY TRAINING AND HABILITATION PROGRAMS ARE OFFERED BY RISE THROUGHOUT THE GREATER TWIN CITIES AREA, SERVING RESIDENTS OF ANOKA, HENNEPIN AND CHISAGO COUNTIES. WE MAINTAIN A FLEET OF 80 VANS AND BUSES TO TRANSPORT PARTICIPANTS TO WORK AND OTHER ACTIVITIES. WE ALSO OPERATE ADULT DAY PROGRAMS FOR PEOPLE WITH BRAIN INJURIES AT COURAGE KENNEY REHABILITATION INSTITUTE IN GOLDEN VALLEY AND FOR OLDER ADULTS AT THE EMMA B HOWE NORTHTOWN FAMILY YMCA IN COON RAPIDS.
