Research In 2014, grants from the Foundation primarily supported Gillette's research and education program The grants offset the \$1 9 million in costs associated with Gillette's research efforts Research is vital to ensuring that Gillette's patients receive the right treatments at the right time to bring about the best outcomes It's also the key to developing effective medical interventions for disabling conditions and their related effects See Schedule O Gillette has four designated research areas gait and motion analysis, pain and comfort, musculoskeletal conditions, and neurological services Gillette has studied human movement, conducting both basic and clinical research that has gained international recognition, for more than 25 years In 2014, Gillette researchers took part in 33 new projects For example, two studies are looking at the effect of standing devices on health and functional ability in people who are generally unable to stand and spend most of their lives seated One study involves children who have cerebral palsy and the other children who have spinal muscular atrophy Another project is studying the long-term effects of selective dorsal rhizotomy surgery on walking ability in young adults In 2014, Gillette doctors and staff published 43 research studies in medical journals and spoke at numerous medical conferences Through its priority areas for coordinated research, Gillette is working to increase the amount and quality of clinically relevant research conducted in the organization In addition, Gillette's expertise benefits people around the world who have disabilities through the organization's participation in fellowships, seminars and other educational programs For physicians who desire in-depth training, Gillette offers residencies and fellowships in such specialties as pediatrics, orthopedics, and pediatric rehabilitation medicine As a teaching hospital, Gillette trains the physicians of the future Residents from the University of Minnesota and Henry Ford Hospital in Detroit spend one to three months under the mentorship of Gillette's medical staff In many cases, Gillette offers physicians their only exposure during residency to patients who have certain disabilities In 2014, Gillette trained 96 residents and 13 fellows in its core specialty areas of orthopedics, pediatrics, neurodevelopmental pediatrics, and rehabilitation medicine Gillette also offers shadowing and mentorship programs for students, along with professional education opportunities in such areas as physical therapy, radiology, nursing, respiratory care and assistive technology Gillette covers the unreimbursed costs of medical education and is fully accredited by the Minnesota Medical Association to provide continuing medical education (CME) for physicians Each year, Gillette sponsors conferences on topics such as cerebral palsy, orthopedics and motion analysis Last year, Gillette provided more than 90 hours of medical education to nearly 1,900 community health care professionals The conferences educate medical professionals about treatment options for children who have disabilities Typical audiences include pediatricians, family practitioners and other physicians CME activities are open to other health professionals Gillette's CME audiences might include nurse practitioners, physician assistants, nurses, physical therapists, occupational therapists, speech and language therapists, orthotists and prosthetists

Patient care The Foundation raises money to support Gillette's patient-care needs In 2014, a significant portion of the money raised for patient care went toward financial assistance and charity care to patients Gillette offers financial aid to those who need it, whether or not they have health insurance and charity care for patients who are financially unable to pay all or part of their medical bills See Schedule O Gillette evaluates each situation based on a patient's income, assets and other resources, and the hospital helps patients set up manageable payment plans (including co-pays and co-insurance) For people who don't have insurance, Gillette charges for care in accordance with the 501[r] guidelines If patients inform Gillette that they will have a difficult time meeting their financial obligations, Gillette will try to qualify patients for public assistance or Gillette's charity care program Income eligibility for Gillette's program is based on national poverty guidelines In addition, this fundraising area provides charitable support to the many areas of Gillette's operations that are unreimbursed or under-reimbursed by third-party payers For example, Gillette holds Outreach Clinics in 14 communities in greater Minnesota A recent community health assessment identified access to specialized care as a major challenge for families who reside in greater (largely rural) Minnesota and surrounding states-but in providing those mission-driven services, Gillette incurs losses Gillette's Outreach Clinics offer services from doctors, nurse practitioners, seating and adaptive equipment specialists, and rehabilitation engineering technologists, providing patients with more convenient and timely health care appointments They also enhance the knowledge base of community providers and improve the quality of ongoing care available in greater Minnesota Similarly, Gillette also provides a variety of services to patients through our Child and Family Services area that are unreimbursed or under-reimbursed Child life specialists help children and families prepare for and cope with hospital stays and medical procedures They offer play therapy, music therapy and positive distractions to help patients understand their health-care experiences and overcome fear and anxiety Social workers provide emotional support and help with practical concerns for families of children who have disabilities, such as ordering medical equipment and finding transportation or other resources Therapeutic recreation specialists help Gillette patients develop healthy lifestyles And Gillette Lifetime Specialty Healthcare offers services for patients 16 and older who have conditions that began during childhood and require lifelong specialty care Gillette treats the age-related effects of cerebral palsy, epilepsy, spina bifida and neuromuscular conditions

Capital In 2014, the Foundation transferred funds to provide capital to expand Gillette's Dentistry and Orthodontics department, open the Gillette Mankato Clinic, and begin work on a therapy pool that will open in St Paul in 2015 Because few traditional dentists have the facilities, equipment or trained staff to serve people who have disabilities, Gillette doubled the capacity of its Dentistry and Orthodontics area at the St Paul Clinic in 2014 See Schedule O Gillette offers care from dentists and orthodontists who understand the unique needs of people who have disabilities and complex conditions Insufficient or irregular dental care increases the risk of tooth decay and oral infections, conditions that can lead to poor nutrition and failure to thrive or heal And physical or cognitive challenges often stand in the way of maintaining oral health People who have cerebral palsy, for example, might have muscles that involuntarily move and tighten, impeding the ability to brush and floss daily And people who have cognitive impairments may be unable to open their mouths on request or may react with such anxiety that they risk harming themselves For such reasons, Gillette patients may need longer appointments up to two hours to receive the same dental work as a nondisabled person Gillette's Dentistry and Orthodontics area now includes five dental bays-an important advancement for patients Gillette provides cleanings, fluoride treatments, X-rays, fillings, crowns, extractions, root canals and soft tissue surgery for people who have disabilities Gillette also offers orthodontia and dental services for children born with cleft lip and/or palate or other craniofacial anomalies In addition, Gillette has custom exam chairs designed to meet the needs of people who have disabilities, a station suited for patients who use wheelchairs, and sedation for patients who are unable to tolerate general dentistry or orthodontia procedures without it To expand care for patients closer to their homes, Gillette increased the number of physician specialties available through its Outreach Clinics and added sites including the Gillette Mankato Clinic Each week in Mankato, Gillette offers services in pediatric neurology, pediatric orthopedics and pediatric rehabilitation medicine One to two times per month, physicians in pediatric craniofacial surgery, pediatric neurosurgery, pediatric spine orthopedics, sleep medicine and specialty pediatrics see patients at the Mankato location A family nurse practitioner and two registered nurses are on-site full-time to coordinate care and refill intrathecal baclofen pumps The Gillette Mankato Clinic also offers assistive technology services for patients who need orthoses, prostheses, custom wheelchair seating and controls, and related equipment The new therapy pool in St Paul will increase Gillette's capacity to offer aquatic therapy to patients Aquatic therapy opens up new possibilities for patients by making movement easier than it would be on land The buoyancy of water reduces stress on joints and helps to support body weight Water also offers resistance, enabling patients to strengthen their muscles In addition, water can decrease swelling, help muscles relax and improve blood flow The result is an ideal environment for patients to improve their abilities and practice skills Gillette offers aquatic therapy in Burnsville and Maple Grove in addition to St Paul Each pool is designed for patients who have disabilities and complex conditions
