THE WHITTIER ALLIANCE SPONSORS AND FUNDS YOUTH PROGRAMS THAT BUILD LEADERSHIP SKILLS AND FOSTER EDUCATIONAL, ARTISTIC AND COMMUNITY GROWTH. THE WHITTIER ALLIANCE FUNDED YOUTH PROGRAMS THAT SERVED 100 WHITTIER YOUTH. THE WA ALSO FOSTERS COMMUNITY COMMITMENT AND RESPONSIBILITY BY SPONSORING PROGRAMS AND EVENTS PROMOTING SAFETY, LIVABILITY, CULTURAL AND INTERGENERATIONAL COMMUNITY BUILDING AND NEIGHBORHOOD INTERACTION. TO GAIN NEIGHBORHOOD STABILITY, THE WHITTIER ALLIANCE OFFERS HOUSING PROGRAMS AND INFORMATION. IN 2014, THE WHITTIER ALLIANCE REHABILITATED TWO SINGLE-FAMILY HOMES. THE HOMES WERE MARKETED TO WHITTIER RESIDENTS AND SOLD WITH A COVENANT THAT THEY REMAIN OWNER OCCUPIED. WORKING WITH RENTAL PROPERTY OWNERS AND HOME OWNERS, PROGRAMS ARE MADE AVAILABLE FOR CURB APPEAL IMPROVEMENTS, CODE COMPLIANCE AND RETENTION OF HOUSING STOCK. THE WA WORKS WITH THE 5TH POLICY PRECINCT TO PROVIDE PROGRAMS AND SEMINARS FOR OWNERS OF PROBLEM RENTAL PROPERTIES. LOW INTEREST LOAN PROGRAMS FOR HOME AND RENTAL PROPERTY OWNERS ARE ALSO PROMOTED.
