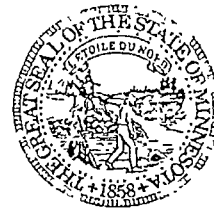

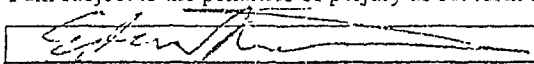

ARTICLES OF INCORPORATION
OF

ARTICLE I.

The name of this corporation shall be True Friends Foundation.

ARTICLE II.

The duration of this corporation shall be perpetual.

ARTICLE III.

This corporation is organized exclusively for the benefit of True Friends, (formerly Friendship Ventures.), a Minnesota corporation, and to these ends to take and hold by bequest, devise, gift, purchase, lease or otherwise any property, real or personal, tangible or intangible, and to sell, convey or otherwise dispose of such property and to invest, reinvest or deal with such property in a manner which best promotes the purposes herein mentioned, and further to solicit donations, gifts and contributions for such purposes.

ARTICLE IV.

The corporation's registered office in the State of Minnesota shall be 10509 – 108th Street N.W., Annandale, Minnesota 55302.

ARTICLE V.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its trustees, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. 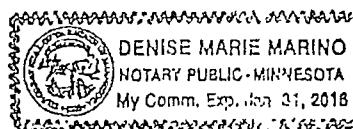
