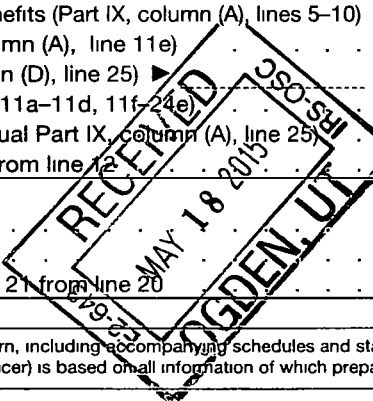

Informed them on federal policy that allows states to create their own health care programs and proposed state policy to implement a cost-efficient program in Minnesota.
Assisted and participated on the board and committees of a doctors, nurses, and citizens coalition that planned and conducted community outreach and education on the issue.

Members visited main street businesses on the costly out-of-pocket costs to consumers in the current health care delivery system and the mis-management and lack of public accountability of tax and premium dollars paid into the system. Attended and monitored state pollution control agency and policy-making hearings on attempts to remove long-standing citizen environmental review authority over potentially damaging corporate agriculture development to communities. Updated members and the general public on the issue
