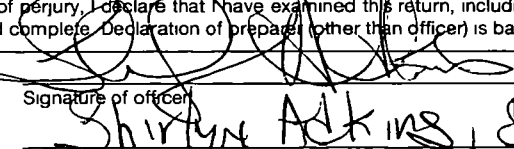

The AANEM Foundation for Research & Education was established to improve the quality of care for people with disorders of skeletal muscle, neuromuscular function, and central and peripheral nervous systems through the promotion of research and education and advancing public understanding of the disorders. It was organized to carry out the charitable, educational, and scientific activities of the American Association of Neuromuscular & Electrodiagnostic Medicine.

Awards: The AANEM Foundation for Research & Education supports its education and research goals by funding several awards each year. Each award gives physicians/investigators the opportunity to be recognized among their peers for their work in research. The awards given include the Golseth Young Investigator Award which is presented to encourage young physicians to conduct research in electrodiagnostic medicine (2 awards, \$2246); the Best Abstract Award is presented to the writer and runner-up of the abstract judged by the AANEM Research Committee as the best based on scientific merit, well written, excellent discussion, importance to the field, and/or fascinating case (2 awards, \$2221); the President's Research Initiative Award is based on abstracts pertaining to an area of interest of the President (9 awards, \$4500); the Junior Member Recognition Award is given to AANEM Physician-in-Training members who are the first and presenting author on an approved abstract to encourage young physicians to conduct research in the fields of neuromuscular and electrodiagnostic medicine (24 awards, \$5191); the Olney Lectureship Award is given to the person chosen to present the titled plenary session at the AANEM Annual Meeting (1 award, \$3003); the Technologist Recognition Award is given to AANEM Technologist members to encourage them to take a leading role in conducting research in neuromuscular and electrodiagnostic medicine (no awards in 2014).

Fellowships: The AANEM Foundation for Research and Education provides fellowship stipends for physicians in economically disadvantaged countries to help them attend the AANEM Annual Meeting. In 2014, four \$1000 stipends were given to physicians from the following countries: Argentina, Brazil, Egypt, and Thailand. In addition to the stipend, the winner's registration fee for attending the AANEM Annual Meeting are waived.

Part II: The American Association of Neuromuscular & Electrodiagnostic Medicine (AANEM) is a 501(c)(6) organization that is supported by activities of the AANEM Foundation for Research & Education (Foundation), a 501(c)(3) organization. The Board of Directors of the AANEM are elected by its members and per the Foundation's by-laws become its Board of Directors.

Part V, Line 1m & 2(2): The AANEM assists the Foundation with fundraising solicitations by including information and appeals in its mailings, emails, and newsletters to its members and allows members to donate to the Foundation when paying dues, registering for meetings, or through its website. All funds collected by the AANEM on behalf of the Foundation are transferred to the Foundation on a regular basis. The total of funds transferred in 2014 was \$40,300, as shown on Part V, 2(6).

Part V, Line 1n, 1o, 2(3) & 2(4): The AANEM owns the building and equipment and allows the Foundation to share the facilities and equipment as well as the services of AANEM employees. The expense for these items is covered by the AANEM on behalf of the Foundation as well as administrative and other office costs that are not program related. The total of facility, equipment, overhead, administrative, and other office costs in 2014 was \$12196 as shown on line 2(3) and the total of employee expenses was \$16221 as shown on line 2(4).

Part V, Line 1p & 2(5): The AANEM pays for airfare, stipends, rooms and other travel and award expenses and is reimbursed by the Foundation for these costs. The total of these reimbursed costs in 2014 was \$20461.
