Transitional Housing - The Dwelling Place acquired two duplexes in addition to the two houses previously used for transitional housing. The new capacity is 16 women and up to 26 children. The homes are very nice, clean, furnished, and have security systems. The homes are located in a residential neighborhood, maintaining the anonymity of the shelter, while providing a genuine home atmosphere. Residents may stay 12 to 18 months to heal, and learn skills for independence. Residents began moving in during the summer of 2014. 2014 statistics: 20 women were served ranging in age from 19-48, 45% African American, 35% white, 5% each of Hispanic, Asian, and Native American, 28 children, ages 3 months to 16 years, 13 boys and 15 girls, 100% below the poverty line and considered homeless by the state of MN.

Domestic Abuse Program and Support Services - The Dwelling Place provides a comprehensive domestic abuse program and support services for residents, including intensive case management, support groups, education on domestic abuse, classes on budgeting and managing finances, parenting skills, self-esteem, Bible Study and spiritual support. Additional features include a Savings Match program (we match their savings up to \$25 per month), a Gift of the Month program (incentives for meeting program and individual goals), and an Education Fund (financial assistance to further their education and professional development), and individual mentoring relationships. In 2014, 6 women with 9 children successfully completed the program and moved to independence and freedom from abuse. All previous graduates responding our survey remained violence free. Twelve women with eighteen children remained in the program at the end of the year.

Community Education - The Dwelling Place provides an information table and speakers to raise awareness of and educate the public about domestic abuse. In 2014, we provided 36 educational opportunities in the community. We also train volunteers throughout the year, providing education on domestic abuse and skills needed for involvement with victims/survivors and their children. In 2014, 317 volunteers provided 3081 hours of service at the shelter. In addition to this 83 volunteers contributed 1862 hours toward the Fall Gala. Over 500 volunteers have helped with remodeling the duplexes. The services of The Dwelling Place are sought after by the community. In 2014, we received calls for help from 422 women with 353 children.
