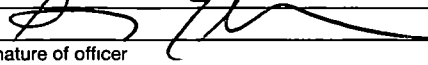
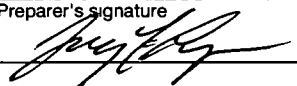

Promoting solidarity and cultural exchange across borders between the people of El Salvador and others in the search for development and dignity. The mission of Los Olivos CIS is carried out primarily via program grants to the Center for Interchange and Solidarity CIS in El Salvador.

Youth Formation and Scholarship Programs. Provides education to potential community leaders who would not be able to study without help and at the same time build their awareness of their role as agents for making changes for social justice. The CIS worked with 15 local Salvadoran committees and organizations and 17 sister organizations as well as individual donors to raise funds for 125 youth to go to the university and 200 to go to high school in 2014. Monthly leadership, formation and analysis sessions were organized for students and their parents by CIS community organizers. Formation and training in the national reality, food sovereignty, roots of violence, violence prevention, election reforms, HIV AIDS prevention, gender equality, self esteem, human rights, climate change, environment, and other themes were carried out with scholarship committees and recipients. Scholarship recipients also carried out volunteer programs including community cleanups, clean water campaign followup, tutoring grade school students in reading and writing, coordinating a health campaign with a clinic, adult literacy classes, and much more. The CIS organized a 3 day retreat and leadership development training for 100 scholarship recipients in La Palma, Chalatenango. CIS School for Solidarity and Social Transformation facilitated a leadership training program for 6 months with 20 community representatives focused on themes of Conflict Resolution, grassroots organizing, solidarity and gender equality.

4b (Code:) (Expenses \$ 135,442 including grants of \$ 103,120) (Revenue \$ 30,478)
Civil rights, democratic development, emergency aid, and advocacy programs. Los Olivos CIS promotes grassroots organizing in various communities. Twenty-nine community organizations currently make up the Community Network for Cooperation and Solidarity. Los Olivos CIS plays a role in the campaign for water rights, food security and sovereignty, and against damaging metallic mining. The CIS also supports educational campaigns of SIGESAL, the public hospital workers association for medical reform and workers rights, and legalization of land titles. CIS provided accompaniment for several communities, assisting with community benefit projects such as land legalization, electricity, computer workshops, community kitchens, latrines, and solar energy. CIS organized its 10th International Election Observer Mission hosted and trained 132 international observers for the 2014 presidential elections and a run off in February and March. There were 10 long term volunteers trained by CIS in international election observation and worked from 3 to 6 months to help coordinate the mission. CLEAN WATER is currently a major focus of CIS community assistance efforts. 452 Sawyer water filters were distributed to 12 communities in 2014 and a total of 1,328 filters to 31 communities since we began the program in 2011. The CIS clean water campaign not only distributes filters and teaches

International cultural exchange and education. Educational delegations and language and cultural exchange. 25 international volunteers taught English classes to 192 local community members during 4 nine week sessions. The volunteers also receive orientation to El Salvador and the empowerment work of Los Olivos CIS. CIS continues coordinating with the University of El Salvador to provide Salvadoran students majoring in English with training and an opportunity to practice their profession and fulfill their 500 hours of social work requirement by teaching at the CIS. 179 international participants received Spanish instruction and cultural orientation from local native speakers. CIS hosted 13 delegations with 145 participants in 2014. Delegates visit El Salvador to gain an in depth understanding of the social and economic reality of El Salvador. The delegation program also promotes solidarity with communities and grassroots organizations working for social and economic justice. CIS hosted the Dominican University Delegation Course on Gender and Human Rights. The delegation had an exchange with and raised funds for art and mental health course for youth in Distrito Italia, Tonacatepeque.
