Community Grants - MOFAS coordinates community grants programs to build the capacity of the state to prevent prenatal alcohol exposure and to identify and support individuals and their families who are living with this challenge. In 2014, four separate rounds of community grants were implemented in communities throughout the state. The grants provided the opportunity to increase early identification and intervention for children with an FASD, create support options in multiple communities around the state, provide culturally specific programming in the American Indian communities, and increase access to employment services for individuals with an FASD. All together, there were 24 grants in progress in 2014.

Intervention and Family Support - Connecting families to resources and supports is the main goal of providing family support. This is an innovative program to connect women who have used alcohol and other substances while pregnant to address the unique challenges they face when parenting a child that has been exposed prenatally. This statewide initiative resulted in partnerships with 12 recovery and treatment programs across the state to serve women currently in treatment who are birth mothers. 1125 women participated in Changing Course. Most of the women served have addiction issues as well as dealing with criminal proceedings and child protection. There were also over 8500 requests from caregivers who needed support. There are 15 different ongoing support groups for caregivers and 368 members on the Virtual Family Center. Our pool of 24 courageous young adult panelists have spoken to ten audiences across the state in 2014. Additionally 15 social events were offered to the transition/young adult aged group.

Public Awareness - To help make FASD more widely understood, MOFAS supported several statewide public awareness activities aimed at educating the general public and specific groups of people on the risks of drinking alcohol during pregnancy. In 2014, a statewide prevention campaign created a strong connection for pregnant women on their choices and the health of their babies. The "Love Hope Joy" campaign was estimated to deliver 44,085,753 impressions (Women 18-34) throughout Minnesota. Additionally, more than 22,000 women of childbearing age received the 049 prevention message at 27 major events across the state. Over 154,000 pieces of public awareness/education materials were distributed through various programs and agencies throughout Minnesota.
