Exhibition Program. Over the past year, we originated 5 world premiere exhibitions from a diverse group of artists based in Berlin, Mexico City, Los Angeles, and Leipzig. These exhibitions presented the work of 5 artists. All the work was commissioned by Midway through our continued artist stipend program. These exhibitions received very positive reviews and coverage in local, national, and international press outlets both trade industry and general public. Public Educational Programs. In addition to exhibitions, our other programmatic efforts have been increasingly strong. We presented performances by artists such as Alexander Hempel, film screenings by American film-maker Storm de Hirsch, lectures from art historians such as Sarah Lehrer Graiwer, David Joselit and Lane Relyea. Lane Relyea's lecture on his most recent book attracted a full capacity crowd in our library with nearly 200 attendees. We continue to provide many tours for area college and university classes. Library. Our research library has continued to grow in its collection and its reach. We have added 1,000 volumes to the collection, which now stands at 6,500 volumes. We are currently working on a major redesign and relaunch of our website with a particular focus on the library's presence. This will be launched in 2015.
