What is the organization's primary exempt purpose?
The organization's primary purpose is exclusively for charitable purposes. The Minnesota Wisconsin Collie Rescue's mission is to provide quality shelter and care for unwanted, neglected, and/or abused Collies until proper permanent homes can be found, to advise and educate potential and current Collie owners about breed characteristics, care, health issues, training, and behavior, to advocate responsible Collie breeding practices, and to promote spaying and neutering of all pets.

Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. In a clear and concise manner, describe the services provided, the number of persons benefited, and other relevant information for each program title.

28 Intake, fostering, and veterinary care for foster Collies. The Minnesota Wisconsin Collie Rescue (MWCR) serves the Upper Midwest including Minnesota, Wisconsin, Michigan, Illinois, Iowa, North Dakota, South Dakota, Nebraska, Kansas, and Missouri. During 2014, the Minnesota Wisconsin Collie Rescue took in homeless Collies and placed them in approved foster homes with experienced Collie owners in eight states for a minimum of two weeks to assess their health and temperament, provided transport to the foster homes, and provided necessary veterinary care. Routinely provided care includes physical examinations with blood work, vaccinations, spaying and neutering, treatment of underlying medical conditions, and heartworm prevention. When needed, MWCR also provides dental cleaning and extractions, surgery for various conditions including broken bones and masses, grooming for severely matted dogs, and behavioral assessment. In many cases, our adoption fees do not cover the amount of money invested in the Collies to ensure their health. MWCR accepts special needs Collies, including those who are elderly, blind, deaf, and have physical limitations. In addition, if a foster Collie has significant medical needs, is deemed to be difficult to adopt, and is in long-term foster care, MWCR will continue to provide veterinary care for the remainder of the dog's life. Adoption of Collies to qualified permanent homes. During 2014, MWCR adoption team volunteers reviewed adoption applications, checked references, visited the homes of potential adopters to meet the adopters and inspect their homes, and when all criteria were satisfactorily met, approved the applications to adopt from us. In 2014, MWCR adopted 65 Collies to permanent homes. In many cases, our transport coordinator organized volunteers who provided transportation to the permanent homes. MWCR provides follow-up with adopters to ensure that the Collie is adjusting to the new home and to answer questions that the adopter might have. MWCR hosts several free Collie Frolics across the region to encourage Collie owners and their Collies to get together, meet and visit with one another, and to provide our Collies with the opportunity to play with each other. Education and Outreach. MWCR strives to educate the public about Collies and the advantages of pet adoption. MWCR partners with the Collie Rescue Foundation, the Collie Health Foundation, the Minnesota No-Kill Alliance, MNPaw, and the Pause 4 Paws organizations to promote responsible pet adoption and to promote strong working relationships among animal organizations. MWCR also collaborates with other local rescues and shelters, such as Red Lake Rosie's Rescue, the Minnesota Sheltie Rescue, and the Minnesota Aussie Rescue to ensure the best placement of animals in need. In addition, MWCR participates in numerous pet-related events during the year, such as the Twin Cities Pet Expo, Great Lakes Pet Expo, the Minnesota Scottish Fair, Responsible Dog Ownership Day, Paws on Parade, and the Dog Days Westonka to promote awareness of MWCR, to educate the public about Collies and rescue organizations, and to promote pet adoptions. MWCR also hosts an annual dinner meeting that includes an educational program for attendees. In 2014, MWCR hosted or participated in 24 public events and fundraisers, including 17 in Minnesota, 6 in Wisconsin, and 1 multi-state event. Our website (www.mwcr.org) contains educational materials for the public, and we routinely use our Facebook page, our newsletter, our blog, and our email group to update people on dog-related health issues, food recalls, health alerts, training and behavioral issues, and other educational items.
