Member Services - The purpose of member services is to recruit and maintain membership is the association and distribute educational material and important information regarding the fields of neuromuscular and electrodiagnostic medicine and ways to improve patient care. This was achieved through: a) member mailings; b) distribution of invited reviews, a professional peer reviewed journal (Muscle & Nerve), email announcements and eNews, and a semi-annual newsletter (AANEM News); c) creation of educational podcasts, practice parameters, consensus guidelines, and position papers; and d) providing information to members through the association website (www.aanem.org).

Annual Meeting/Education and Publications - The purpose of the Annual Meeting is to provide physicians with a large forum to exchange ideas and provide continuing education for updating and acquiring greater knowledge about the diagnosis and treatment of neuromuscular and musculoskeletal diseases. The meeting also offers an opportunity to learn, enhance and/or refresh electrodiagnostic and other diagnostic techniques to improve patient care. This was achieved through a variety of hands-on interest workshops, courses, expert roundtables, discussion groups, demonstration sessions, symposia, plenary lectures, special group sessions, abstract reviews and presentations, industry forums, and an exhibit hall containing the latest equipment, supplies, books, periodicals, and pharmaceutical treatment options to aid and improve patient care. The purpose of Education and Publication services is to distribute educational materials to physicians interested in the fields of neuromuscular and electrodiagnostic medicine to strengthen physician competence. This purpose was achieved by providing printed educational materials, videos, DVDs, CD-Roms, teleconferences, online learning activities, regional meetings, and brochures to educate physicians, allied health professionals, patients, and the general public. The material provides information about the field, explains the procedures used to diagnose neuromuscular and musculoskeletal diseases, and discusses treatment options. The goal is to improve patient care.

Professional Standards - The purpose of Professional Standards is to use the certification of physicians and technologists and accreditation of electrodiagnostic laboratories to set and monitor standards to improve patient care and the quality of neuromuscular and electrodiagnostic medicine. This was achieved through certification examinations for both physicians and technologists, requirements to participate in continuing medical education (CME) activities and maintenance of certification examinations, and electrodiagnostic laboratory accreditation, a peer-review process that acknowledges laboratories for achieving and maintaining the highest level of quality, performance, and integrity based on professional standards, to promote a structured mechanism to assess, evaluate, and improve patient care.

Part 2: The American Association of Neuromuscular & Electrodiagnostic Medicine (AANEM) is a 501(c)(6) organization that is supported by activities of the AANEM Foundation for Research & Education (Foundation), a 501(c)(3) organization. The Board of Directors of the AANEM are elected by its members and per the Foundation's Bylaws become its Board of Directors.

Part V, Line 1b & Line 2(1): The AANEM Board of Directors approved a \$25000 contribution to the Foundation.

Part V, Line 1l & Line 2(2): The AANEM assists the Foundation with fundraising solicitations by including information and appeals in its mailings, emails, and newsletters to its members and allows members to donate to the Foundation when paying dues, registering for meetings, or through its website. All funds collected by the AANEM on behalf of the Foundation are transferred to the Foundation on a regular basis. The total of funds transferred in 2014 was \$40300 as shown on Part V, Line 2(6).

Part V, Line 1n, 1o, 2(3) & 2(4): The AANEM allows the Foundation to share its facilities and equipment as well as the services of its employees. The expense for these items is covered by the AANEM on behalf of the Foundation as well as administrative and other office costs that are not program related. The total of facility, equipemnt, overhead, administrative, and other office costs in 2014 was \$12196 as shown on line 2(3) and the total of employee expenses was \$16221 as shown on Line 2(4).

Part V, Line 1q & 2(5): The AANEM pays for airfare, stipends, awards, rooms and other travel and award expenses and is reimbursed by the Foundation for these costs. The total of these reimbursed costs in 2014 was \$20461.
