PUBLIC RELATIONS The Company supported 4-H & FFA activities and programs along with other local agriculture related groups with monetary donations & participation in activities. Hosted two Stroke Detection Plus screenings for members and community with 48 participants. Sponsored Farm Succession and Estate Transfer workshops and Farm Bill educational meetings free to members. Hosted an annual meeting for all members to display and promote member benefits and activities of the organization. 95 attended at a cost of \$1,100. Sponsored a local cookout contest at County Fair, educating public on food safety and nutrition, promoting quality Iowa meat. Several hundred fair attendees stopped during the cookout contest. News releases and letters to the editor about the Company and its activities and issues affecting agriculture. Promoted Natl Ag Day with advertising, news releases and Farm Bureau leaders visiting with the public at a local grocery store. Shoppers were presented with ag related trivia and coupons given away for their food purchases.

EDUCATION The Company strongly supports agricultural education and has worked very hard at keeping local schools and students aware of how important agriculture is. The ways they have accomplished this is with an active Ag In The Classroom committee communicating to teachers, educators and schools promoting resources and grant opportunities available to incorporate agriculture into the classrooms. The Company also provided scholarships to high school seniors for college tuition totalling \$2,000. Participated with the 3rd Grade Ag Education Day for area schools. 325 third grade students in Benton County gathered at the county fairgrounds for a day of educational tours and informational booths. Participated in a Farm Safety Day Camp for 4th, 5th and 6th grade students in the area. Volunteers educated attendees about the hazards around the farm and promoted safety. Sponsored young farmers to attend the Iowa Farm Bureau Federation Young Farmer Conference & informational meetings. Presented a local HS with a \$5000 donation to build an Animal Learning Lab for area students.

POLICY DEVELOPMENT Members met several times with elected state and national officials to discuss the importance to agriculture. Wrote letters & emails to Congressional elected officials and EPA on Renewable Fuels Standard and Waters of the U.S. to support 1,720 members policy. Met with county board of supervisors and county officials discussing budgets affecting the company's members. Committee formulated a survey for members. This was made available to all members and encouraged them to participate in the grassroots policy development process. Policy was written based on results of the survey for the ag communities. Promoted, supported and educated members and the public on the many Nutrient Reduction Strategy programs, working together with other ag groups, so farmers may be proactive and not face additional regulation. Issue surfacing meetings were held where members were encouraged to surface, post and prioritize rural and ag related issues through emails and on-line. An active PAC went to training and held meetings. Candidate forms were reviewed with recommendations.
