PUBLIC POLICY The Company was very active lobbying county supervisors, state legislators and congressional leaders. The Company's Board of Directors met with County Supervisors, County Engineer and Auditor to review/scrutinize the 2014-2015 budget and also lobby for additional funding for rural roads/bridges. Board members met with state legislators prior to the start of session to lobby for Farm Bureau policy and also met with with state legislators during the entire legislative session. The Board President attended the American Farm Bureau annual meeting to lobby for the best interests for national agricultural policy. Hosted an annual meeting for over 2100 members. Members were given the opportunity to elect the board of directors and sign a petition asking the Army Corp of Engineers and Environmental Protection Agency to withdraw their newly proposed "Waters of the United States" regulations. Over 250 petitions were signed that

EDUCATION/AG IN THE CLASSROOM The Company helped sponsor a four county-wide 5th Grade Youth Environmental Days at the Wright County Fairgrounds in Eagle Grove. Approximately 800 students attended one of the four day event where they learned about by-products that come from corn/soybeans, farm-to-market, farmers feeding the world along with other agricultural related sessions. The Company also provided a series of agriculture breakout sessions to all of the students at the Duncombe Elementary School (500+ students). The sessions were taught by three Ag In The Classroom teachers over a three day period of time. The Company also donated funds to the Webster County 4-H Foundation and provided 2 - \$1,000 college scholarships to two graduating Farm Bureau member high school seniors.

AGRICULTURAL PROMOTION The Company donated \$2,000 to the Almost Home Pet Shelter where all animals that are adopted are injected with a microchip should the pet ever be lost or stolen. The Company co-sponsored a two day Farm News Ag Show held in Fort Dodge that was attended by over 2,000 local farmers at a cost of \$1,000. The Company was also the corporate sponsor of the Dayton Rodeo that was attended by over 3,000 over the three day event at a cost of \$1,000. The Company is a corporate sponsor of the Fort Dodge "Farmers Market" which is held every other weekend during July through August. Sponsorship was \$500 and the Company also provided free America Needs Farmers t-shirts at a cost of \$1,050. Over 12,000 people attended the Farmers Market throughout this period. The Company promoted Ag Week in March by conducting a \$300 shopping spree. While the shopping spree in taking place board members are on the radio informing the listening audience (5,000+) about the significant role agriculture play in their daily lives at a cost of \$1,313.
