PUBLIC POLICY Activities were conducted locally with the county annual meeting and the Johnson County Court House/Judicial Center Bond referendum. September 17th was the annual meeting with 210 members attending. Accomplishments for the year were reviewed to those in attendance, election of officers and directors occurred along with the surfacing of issues the Company should engage in. Ideas ranged from common core, support for wind generated electrical transmission line, county road dust control and installation of center line on county roads were some of the 8 issues raised by members. These issues were exchanged at a regional policy development meeting held in November. Members met with the county supervisors and county engineer personnel regarding various county issues.

AG EDUCATION The Company places great emphasis on educating tomorrow's leaders especially those pursuing a career in agriculture. The Johnson County Farm Bureau provides scholarships to youth of members that are pursuing a college education. Youth complete applications and are interviewed by the scholarship committee. Three scholarships were awarded totaling \$2,500 during the year.

AGRICULTURAL PROMOTIONS The Company conducts two main events in the county to inform the general public of the importance of agriculture, Spring Ag Fest and the Johnson County Fair Heritage Barn. The Ag Fest occurred May 18th. Various commodity groups, area banks, Iowa State Extension along with Company volunteers operate educational booths & provided the 410 attendees information regarding responsible agricultural production practices. At the Johnson County Fair, Company volunteers staff the Heritage Barn during the 4 day fair showcasing farming equipment and practices past and current. Small animals are provided for viewing and petting as demonstrations of sheep shearing, wool spinning, ice cream making are conducted. The Company is a main sponsor of the main stage in the center of the fairgrounds where all events are either conducted or broadcast from.
