During July 1 to December 31, 2014, the Center's outpatient services provided over 10092 initial evaluations, individual and group therapy and medication management services to approximately 6000 individuals. The Center also provided services to the homeless, school based and community based individuals, nursing triage services, patient assistance medications, peer support services and an integrated mental health home.
