After our annual campaign, a group of community volunteers come together to allocate campaign dollars to social service agencies that serve Mahaska County. In 2014, United Way of Mahaska County funded 11 local agencies. These agencies focus their efforts on addressing education, income, health and basic needs throughout Mahaska County.

5K & Healthy Kids Day: Each spring gives us warmer weather and an opportunity to get outside to exercise and have fun with our families after a long winter. Together with Mahaska YMCA, we offer a 5K & Healthy Kids Day to highlight our local agencies and other agencies that promote healthy living. Through participating in this event, agencies are able to inform the public of the wonderful services they provide to Mahaska County residents. Community members can participate in our 5K Run/Walk and then celebrate with family and friends. We tailor the day towards families, as we know the importance of building strong family relationships. Prizes are given away, a free picnic lunch is provided, and fun is had by all.

Operation Backpack/Stuff the Bus: Each summer, United Way of Mahaska County sponsors Stuff the Bus, a school supply drive to gather supplies for Operation Backpack. Operation Backpack provides school supplies to Mahaska County children in low income families. Any child or youth (preschool through 12th grade) residing in Mahaska County is eligible for the program. In 2014, we supplied over 400 backpacks to families in need. Leftover school supplies were given to local schools to stock school supply closets which can be utilized by teachers throughout the school year. We partnered with SIEDA, Salvation Army and the school districts in Mahaska County.

Designated Gifts: Expenses - \$31,173 (including grants of \$31,173) - United Way of Mahaska County accepts designated donations from donors during the annual fundraising campaign. Donations are forwarded to designated human service 501(c)3 agencies.

Special Grants: Expenses - \$27,500 (including grants of \$27,500) - United Way of Mahaska County provided Special Grants to 5 local agencies in Mahaska County. Programs funded included helping pay for basic needs, programming supplies, service equipment and building equipment repairs.

Community Impact: Expenses - \$6,702 - United Way of Mahaska County is expanding its reach into the community by helping form coalitions/groups of interested parties to address needs in the community. The areas of impact that we focused on in 2014 included transportation, healthy living and childhood hunger.

VITA Tax Site: Expenses - \$2,019 - United Way of Mahaska County recruits volunteers, coordinates and hosts a VITA Tax Preparation Assistance Site. IRS Certified VITA Tax Preparers provide free tax preparation for low income families and individuals.

Volunteer Center: Expenses - \$1,537 - United Way of Mahaska County operates a Volunteer Center in Mahaska County. Local agencies are able to post volunteer needs on the Volunteer Center website. Community members can access the website to find volunteer opportunities that match their interests and availability.

Day of Caring: Expenses - \$1,419 - United Way of Mahaska County empowers volunteers in our community to come together to assist in completing projects for those in our community that might not otherwise be completed. We organize volunteers to work on a variety of projects each year, including those that serve seniors and individuals with disabilities, city and county projects, local non-profit agencies, and schools. In 2014, we completed 18 projects with approximately 100 volunteers.

Winter Coat Drive: Expenses - \$0 - United Way of Mahaska County provided promotion support for the local Coat Drive, in partnership with New Hope Community Center. We also provided manpower for distribution of collection boxes and regularly collected coats and other winter outerwear items and delivered them to New Hope, where they were available to the public for free.

Literacy Program: Expenses - \$0 - United Way of Mahaska County has a unique program for members of our community. In our lobby we house numerous used books and magazines that are free to the public. We have a variety of options to choose from for all ages. All materials are donated by local residents and United Way incurs no cost in providing this resource to the community.
