


Part I, #2 - All funded agencies are required to complete an annual funding request as well as attend an allocation hearing. Board members serve as liaisons to the agencies. Board members are expected to keep constant communication with agencies to discuss program successes and challenges. Agencies also required to submit a mid-year report which tracks program outcomes and other challenges incurred over the past six months.
