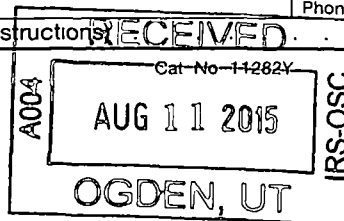

SERVICES INCLUDE BATHING AND LAUNDRY FACILITIES, A MAILING ADDRESS, A PLACE TO RECEIVE PHONE CALLS & MESSAGES AND BREAKFAST AND DINNER. SHELTER HOUSE FOOD SERVICE IS NOT ONLY FOCUSED ON MEETING THE NEEDS OF OUR RESIDENTS BUT ALSO CONTRACTS OUT MEAL PRODUCTION FOR AREA NON-PROFITS AND BUSINESSES. SHELTER HOUSE OFFERS A 12 WEEK CULINARY TRAINING PROGRAM, THROUGH WHICH TRAINEES ARE MORE COMPETITIVELY POSITIONED FOR EMPLOYMENT IN LOCAL RESTAURANTS AND COMMERCIAL KITCHENS. THE DROP-IN CENTER PROVIDES A RANGE OF SERVICES INCLUDING BATHING AND LAUNDRY FACILITIES ACCESS TO PHONE, ACCESS TO PROFESSIONAL STAFF, TOILETRY AND CLOTHING DONATIONS, AND BUS TICKETS. SERVICES ARE AVAILABLE DAILY ON A WALK-IN BASIS FOR ANYONE IN NEED. A NURSE MANAGED HEALTH CLINIC, OUTREACH FROM THE VA, PRO BONO LEGAL SERVICES, COUNSELING SERVICES, AND PAYEE SERVICES ARE AVAILABLE WEEKLY.
