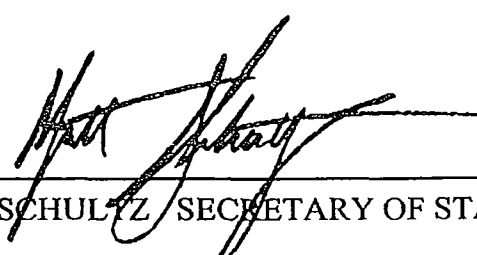

AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
FAMILY MANAGEMENT CREDIT COUNSELORS, INC.

TO THE SECRETARY OF THE STATE OF IOWA:

The undersigned nonprofit corporation, organized under Chapter 504A of the Code of Iowa, hereby amends and restates its Articles of Incorporation, in accordance with the Iowa Revised Nonprofit Corporation Act, Chapter 504 of the Code of Iowa as follows:

ARTICLE I

NAME OF THE CORPORATION

The name of the corporation is Family Management Financial Solutions, Inc. (hereinafter, the "Corporation").

ARTICLE II

DURATION

The existence of the corporation shall continue perpetually unless dissolved as provided by law.

ARTICLE III

PURPOSES AND POWERS

The corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue code of 1986, as amended. The primary purpose of the corporation includes, but is not limited to, the following:

1. To educate, counsel and advise debtors with regard to the intelligent use of consumer credit and the careful budgeting and management of money.
2. To negotiate with creditors on behalf of debtors for the purpose of designing and administering debt liquidation plans and distributing payments.
3. To render all other advice and services related to the above.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except as otherwise may be permitted in Section 501(h) of the Internal Revenue Code of 1986, as amended. The corporation shall not participate in or intervene in (including the publishing or distributing of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

Notwithstanding any other provisions of these Articles, the corporation shall not conduct or carry on activities no permitted to be conducted or carried on by any organization exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or by any organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended.

As a means of accomplishing the foregoing purposes, the corporation shall have all of the general powers set forth in Chapter 504A of the Code of Iowa (1991), and as it may hereafter be amended. These general powers shall be exercised exclusively for the attainment of the purposes of the corporation as set forth in this Article.

**ARTICLE IV**  
**NO PRIVATE INUREMENT**

No part of the net earnings shall inure to the benefit of any director or officer of the corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes). No director or officer of the corporation, or any private individual, shall be entitled to share in the distribution of any of the corporate assets on the dissolution of the corporation.

**ARTICLE V**  
**DISSOLUTION PROVISIONS**

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the remaining assets of the corporation exclusively for the purposes of the corporation set forth in Article III hereof in such a manner or to such organization or organizations operated exclusively as charitable organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations as said District Court shall determine which are organized exclusively for such designated purpose(s).

**ARTICLE VI**  
**REGISTERED AGENT AND REGISTERED OFFICE**

The address of the registered office in the State of Iowa is 359 Rock Island Avenue, Waterloo, Black Hawk County, Iowa 50701. The name of the registered agent at such address is Katy M. Hackett.

**ARTICLE VII**  
**DIRECTORS**

The business affairs of the corporation shall be managed under the direction of its Board of Directors. The number of directors shall be fixed by the Bylaws and may be increased or decreased from time to time by amendment to the Bylaws.

**ARTICLE VIII**  
**MEMBERS**

This corporation shall have no members.

**ARTICLE IX  
NONLIABILITY**

Except as otherwise provided by law, a director, officer, employee, or member of the corporation is not liable for the corporation's debts or obligations and a director, officer, member or other volunteer is not personally liable in that capacity, for a claim based upon any action taken or failure to take any action in the discharge of a person's duties, except for a breach of the duty of loyalty to the corporation, for acts or omissions not in good faith or which involve intentional misconduct or knowing violation of the law, or for a transaction from which the person derives an improper personal benefit or permit further elimination or limitation of the liability of the corporation's directors, officers, employees, and volunteers, then the liability of the corporation's directors, officers, employees, and volunteers shall be eliminated or limited to the full extent permitted.

**ARTICLE X  
AMENDMENTS**

These Article of Incorporation may be amended at any time and from time to time as provided by the Code of Iowa, but no amendment shall be adopted which deprives the corporation of tax exempt status under the Internal Revenue Code of 1986, as amended.

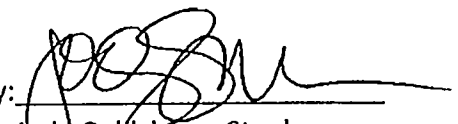
**ARTICLE XI**

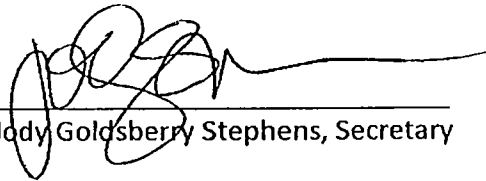
