THE SITE ALSO INCLUDES A DIRECTORY OF SERVICE AGENCIES AND OTHER RESOURCES TO HELP WOMEN AND GIRLS. THE FOUNDATION HELD ITS ANNUAL LUNCHEON THAT WAS ATTENDED BY OVER 500, AND A DINE AND UNWIND EVENT ATTENDED BY 65. BOTH EVENTS PROMOTED COLLABORATION, MENTORING AND NETWORKING. A SHE MATTERS MAPPING TOOL WAS PRODUCED AND SHARED AT FIVE TRAINING SESSIONS ACROSS THE STATE.

50-50THE 50-50 PROGRAM IS A BIPARTISAN INITIATIVE TO ACHIEVE POLITICAL EQUITY IN IOWA BY RECRUITING, TRAINING AND MENTORING WOMEN IN SUFFICIENT NUMBERS THAT BY 2020 IOWANS WILL HAVE ELECTED FEMALES TO FILL 50% OF THE IOWA LEGISLATURE, CONGRESSIONAL SEATS AND OFFICE OF THE GOVERNOR. THE PROGRAM CONDUCTS SEMINARS AND WORKSHOPS THAT GIVE WOMEN A GREATER OPPORTUNITY TO LEARN ABOUT THE OPERATIONS OF THESE OFFICES AND TO OBTAIN ADVICE AND MENTORING. '50-50 IN 2020' WAS RECOGNIZED BY THE IRS AS A SEPARATE 501(C)(3) EXEMPT ORGANIZATION IN 2014 TO TAKE CHARGE OF THIS ACTIVITY SEPARATE FROM IWF.
