These meetings and support create strength and a collective voice in representing the needs of the region to and with larger foundations and corporations, supply partners, vendors, and government agencies. The SKCFC also initiates and works to lead coordinated efforts on large project opportunities, including fundraising and marketing to benefit all agencies that are members of the coalition

Emergency Food Assistance Program (EFAP) lead agency/contractor

The SKCFC administers and manages a contract with Washington State Dept. of Agriculture that provides funds for food banks

These funds are utilized by participating food banks in a variety of ways to support and strengthen the positive impact of their services in their communities. How this grant is allocated across the participating food banks for South King County is determined by vote on an allocation formula agreed to by agencies. These funds are then used for food purchases, staffing costs, equipment repair costs and any other needs directly related to providing strong reliable services and nutritious food to people in need

The SKCFC administered grant funds out to 12 member agencies in the 2013-2014 state grant cycle totalling \$225,359, and \$293,973 in the 2014-2015 grant cycle while keeping expenses to a minimum, with only 3.89% of the grant going towards administrative expenses
